TODD WILCOX

Todd Wilcox is a decorated combat veteran, a former CIA case officer and a successful entrepreneur and business leader, recently recognized as an Ernst and Young Entrepreneur of the Year 2015 finalist. Todd is a devoted husband and father of three daughters and lives with his family in Orlando.

With a single mother working two jobs to make ends meet, Todd was at times the primary caregiver for his younger siblings in the South Tampa low income neighborhood where he grew up. At age 13, Todd got his first job washing dishes in the TECO (Tampa Electric) cafeteria. Later in his teen years, with the help of a mentor, Todd realized that he was hanging out with the wrong crowd and his life was heading in the wrong direction. His mentor convinced him that an education was his only chance to break out of poverty. Todd buckled down and graduated from Tampa's Robinson High School and earned an Army ROTC Scholarship to the University of Tampa.

After earning his degree in finance, Todd was commissioned as an Infantry Officer in the U.S. Army. He went on to serve as a rifle platoon leader with the 101st Airborne Division during Operation Desert Storm. Upon promotion to Captain, Todd volunteered for a transfer to the U.S. Army Special Forces branch and after earning his Green Beret he commanded a Special Forces A-team in a counterterrorism role in East Asia. After eight years of military service, Todd resigned to accept a position with the CIA to join America's global war on terrorism. While completing two years of Arabic studies and then serving from various U.S. Embassy postings in the Middle East and North Africa, Todd was also raising two daughters on his own as a single parent. His last assignment with the CIA was on the Joint Terrorism Task Force in the FBI field office in Orlando.

In 2006, Todd left government service and created Patriot Defense Group (PDG), a defense contracting company dedicated to serving those who defend America. Todd founded two other companies and the combined business operations over the past nine years range from specialized security training for U.S. special operations to defending corporate clients against cyber-security attacks and the ground delivery of the U.S. Postal mail to our troops in Afghanistan.

Todd's business success has been recognized by the Wall Street Journal and through awards such as Orlando Business Journal's "Veterans of Influence." His military and national security expertise earned him a seat on the board of directors of the National Defense University Foundation and the board of advisors for the Rand Corporation Center for Middle East Public Policy.

MEMBER OF THE MONTH

Attorney Ita Neymotin, the Regional Counsel for the Office of Criminal Conflict and Civil Regional Counsel for the Second District Court of Appeal of Florida, has been reappointed to her post by Governor Rick Scott. She has served in this capacity since 2011, when she became the youngest attorney and the only woman appointed in the state of Florida. Now at age 43, she maintains those distinctions among all five District Court of Appeal regions across the state.

She is responsible for the 14 counties that make up the Second District Court of Appeal, managing 140 attorneys and support staff with an annual budget that exceeds \$9 million. The Regional Counsel defends parties when the Public Defender's office has a conflict in a case. The office also represents indigent clients in juvenile dependency as well as certain types of civil cases. Neymotin is responsible for the counties including Lee, Collier, Hendry, Charlotte, Glades, DeSoto, Hardee, Highlands, Polk, Pasco, Pinellas, Hillsborough, Manatee, and Sarasota Counties.

Neymotin's original appointment in 2011 represented a return to the Regional Counsel, as she had served as a trial attorney and chief for the office from 2007 to 2010. She practiced with the Office of the Public Defender for the Twentieth Judicial Circuit from 2004 to 2007, the Kremenchuker Law Firm P.A. from 2003 to 2004, and the Office of the State Attorney for the Twentieth Judicial Circuit from 2002 to 2003. Neymotin received a bachelor's degree from Ohio State University and a law degree and Master of Laws from Capital University Law School. She is reappointed for a term ending September 30, 2019.

Neymotin is also chair of the Local Professionalism Panel for the Twentieth Judicial Circuit, and is a frequent speaker on professionalism issues for agencies and conferences across Florida. She was the recipient of Capital University Law School's 2015 Distinguished Alumni of the Year Award. Upon the invitation of the Ukrainian government, she visited that country to advise its officials on improving their system of justice, enhancing its public image and dealing with the problem of selective persecution. Neymotin is on The Florida Bar Grievance Committee, and was the 2015 Medal of Honor recipient from the Collier County Bar Association. She also teaches the Florida Criminal Law and Procedure Class at Ave Maria Law School.



Wife of President Ulysses S. Grant



Americanism Republican First Ladies

Julia Grant served eight years as First Lady. She enjoyed entertaining and fashion. After furnishing the private quarters of the White House within the \$30,000 allotted by Congress, she obtained another stipend of \$100,000 to redo the first-floor rooms. She allowed her teenage son to railroad across the country to California, naively accepted gifts from dignitaries as personal gifts while using her political savvy to advise her husband on his appointments. Julia was in her element.

She was raised in an upper class household on a farm outside of St. Louis, Missouri. Her mother immigrated from England where the family owned an import-export company dealing in trade with China. Her father was a successful fur trader and owner of a steamboat hauling commercial goods on the Mississippi. He built the family home with the help of his thirty slaves. It was there that Julia was born in Jan. of 1826, the fifth of her parents' children. Her father gave her, at her birth, a slave girl, Julia aka Jule, slightly older who would be Julia's companion for half their lives. She boarded at a school in St. Louis from ages 10 to 17.

Otherwise, she preferred hunting, riding, and fishing. Her report card probably would have stated: 1. needs improvement 2. is not applying herself. She adored her father and he her. Julia loved dancing. She wasn't above betting on cards or horses and enjoyed the occasional glass of wine or two.

In 1844, her older brother, Fred, a cadet at West Point, brought home a friend, Ulysses S. Grant. Engagement to Grant quickly followed. They wed four years later in 1848 after the Mexican American War. She was 22 and he was 26. Within the next 10 years, they had four children. In 1852, Ulysses was assigned to Humboldt Bay, CA. Missing Julia, he resigned from the Army to take up farming. Julia reportedly cried out to God above asking if this was how she would live the rest of her life. Ulysses gave up farming and became a clerk in his father's tannery in Galena, Ill.

Then the Civil War broke out. Ulysses was reinstated as a Colonel by the State of Illinois serving in the 21st Infantry. Two months later, Lincoln appointed him Brigadier General. Julia became a very astute diplomat. She shared her father's Democrat leanings believing in states' rights and in the right to own slaves. She held four of her own. She believed, as her husband did, that it was the federal government's right and duty to hold the Union together. She was totally devoted to her husband and was a soldier's wife ready to face the difficulties. The Grants' devotion to each other was never more so than during the war years. Grant insisted that his wife and family be near as long as it was deemed safe. reportedly had a drinking problem. His wife and children were his support group. At no time during the war did anyone ever accuse him of being drunk. The family faced the war together. Their son Fred, age 12, was grazed by a bullet while watching the battle at Vicksburg. Julia and Jule, traveling at the time, missed being captured when Confederates raided the home. Both she, the children, and Jule, thanks to photography, were targets of kidnappers. Jule, if caught, would have gained the Confederates great publicity focusing on the hypocrisy of Grant fighting against slavery while his wife kept slaves. Jule never attempted to run even in free Illinois. She continued with Julia even working with her nursing both Union and Confederate soldiers. Finally, at 37, she ran when the family was in Louisville, Kentucky. Although this was probably upsetting to Julia, General Grant could have seen it as an answer to his prayers. Julia had to face the loss of southern friends and family who saw the Grants as Lincolnites, and from northerners who saw her as a "secesh" (one who is pro secession) and a slave owner. Towards the end of the war, the Philadelphia Union Club provided a house for the family worth \$30,000. Julia lived on Chestnut Street with the children leaving only to visit her husband wherever he was headquartered. After the war, the family returned to Galena greeted by 10,000, a victory parade and a furnished brick home.

Julia had a sixth sense. Upon meeting Ulysses for the first time, Julia said, "He's going to be President." She dreamed that he would return after their first meeting and propose. He did. She heard a voice telling her she would not live her life at Hardscrabble. In 1871, planning a trip to Chicago, she dreamed of a fire and canceled her trip avoiding the tragedy which occurred shortly after. Days before the Lincoln assassination, she saw a man in her neighborhood who frightened her and feared for the safety of her family. Quickly, she planned a trip to New Jersey and politely declined the Lincolns' invitation to the theatre that April night.

Having won the 1868 election, the Grants moved into 1600 Pennsylvania Ave. She held receptions for the public opening them, for the first time, to all races. She also advised the black staff on how to handle their finances and purchase homes. She quietly supported a dying black war veteran who had to leave his job at the White House providing for his medical and daily needs. She was instrumental in obtaining a pardon for a Union soldier found guilty of desertion when he ran home to be with his wife during childbirth. She was criticized for her weight, dress, and perceived haughtiness. But most, including the press, found her down to earth, genuine and kind. After leaving the mansion they settled in New York City where Julia took up a position of society grand dame entertaining foreign dignitaries and the elite. She also became friends with the other First Ladies and an active participant in Washington society. She became an active supporter of women's suffrage with Susan B. Anthony believing that women could maintain a home and vote. She had strong opinions on the necessity of women holding their marriages together reminding them to keep love and romance alive in their homes. In 1884, President Grant got throat cancer and suffered a financial setback having involved himself, against Julia's objections, in a Ponzi scheme. He decided to write his memories hoping that the money from the book's sale would provide for Julia. He died a week before it was published. The book, published by Mark Twain, earned Julia \$400,000. Julia was both stoic and cheerful while nursing her husband but too filled with grief to attend her General's funeral. She died in 1902. She was 74.

Legislative UPDATE

Since the School Year is drawing to a close and on Capital Hill the Congressmen and Congresswomen as well as the 50 state Senators are busy passing Legislation which will affect the Public Schools, I thought this would make for interesting reading.

House Child Nutrition Reauthorization Bill Clears Committee

The House Education & the Workforce Committee approved the Improving Child Nutrition and Education Act of 2016 (HR 5003) on May 18 with a largely partisan vote of 20 - 14. More than two dozen amendments were considered. Ultimately, HR 5003 was approved.

Both chambers now have committee-passed bills to reauthorize six major nutrition programs-including school breakfast and lunch. The Senate bill is the Improving Child Nutrition Integrity and Access Act (ICINA) and was approved by the Senate Agriculture Committee in January 2016.

Local school board engagement: Both bills increase stakeholder engagement - including school boards - in policy and implementation by the U.S. Department of Agriculture. For example, both the House and Senate bills would establish a School Nutrition Advisory Committee (SNAC) to advise the Secretary, and the Committee would include a school board representative. The House bill includes an additional provision for triennial review of national standards, and a requirement to consult with school boards as part of the process. Further, the House bill includes an ESSA-like provision prohibiting the Secretary from establishing regulations or requirements not explicitly authorized by statute.

Senate HELP Committee Convenes Third Oversight Hearing on ESSA Implementation

On May 18, the Senate Health, Education, Labor and Pensions (HELP) Committee held a hearing entitled, "ESSA Implementation: Perspectives from Education Stakeholders." Chairman Lamar Alexander (R-TN) convened the hearing to discuss concerns over the U.S. Department of Education's (ED) negotiated rulemaking regulatory proposal on Title I supplement, not supplant (SNS) and the unintended consequences of this regulation. This is the third of six HELP Committee oversight hearings related to ESSA implementation.

Career and Technical Education Reauthorization

The Education and the Workforce Committee held a hearing this week to discuss recommendations for reauthorizing the Perkins Career and Technical Education (CTE) Act. Last reauthorized in 2006, CTE provides more than \$1 billion to states and school districts annually to help support curricula and training for students, including apprenticeships and credentials needed in the workforce. During the hearing, both witnesses and Committee members noted the success of CTE programs and provided insight about efforts underway to align CTE programs with local and regional workforce demands. Sen. Tim Kaine (D-VA) testified before the Committee and discussed efforts he is championing in the Senate to support greater opportunities for college and career readiness, such as dual enrollment and expanded partnerships with business and industry.

Changes to Labor's Overtime Rules

On May 18, President Obama and Secretary Perez announced the publication of the Department of Labor's final rule updating the overtime regulations under the Fair Labor Standards Act (FLSA). The rule, which does not impact teachers and administrators, will go into effect for public, private and non-profit employers on December 1, 2016. To date, Congress has conducted several oversight hearings of the Department of Labor to examine the requirements of the rule. Now that the Department of Labor is taking final steps to finalize the rule, individual members of Congress have stated that they are evaluating and considering ways to delay or nullify the rule prior to the rule becoming effective.

NSBA has initially reviewed the final rule and identified the following changes affecting school districts as employers:

1. Rule: Though the U.S. Department of Labor's (DOL) new overtime rule is anticipated to be published on May 23, 2016, the final rule does not take effect until December 1, 2016.
Implications: This could be a challenge for school districts, because by this time in a school district's calendar, most school districts have likely already prepared their budgets for the upcoming 2016-17 school year.
2. Rule: Although the executive, administrative, and professional exemptions expressly apply to an "employee employed in the capacity of academic administrative personnel or teacher[s]," the salary level and salary basis requirements do not apply to bona fide teachers.
Implications: Administrators and teachers are exempt from the overtime rule, and are not eligible for overtime compensation.
3. Rule: The minimum salary threshold for all non-highly-compensated employee categories (executive, administrative, and professional) is \$47,476/year, based on the lowest-wage Census Region (Southern).
4. Rule: The minimum salary threshold for all highly compensated employees has been raised to \$134,004/year.
Implications: This higher threshold means more highly paid school district employees will be ineligible for overtime under the rule.
5. Rule: The proposed annual update to the minimum salary threshold has been changed from every year to every THREE years, setting the date for the increase to a firm January 1st date, beginning on January 1, 2020.
Implications: A longer period for threshold changes means school districts do not have to anticipate yearly budgetary changes. Thus, a school district can prepare for the January 1, 2020 increase during the 2019-20 SY budget planning in early Spring 2019.
6. Rule: The final rule allows employers to include NON-discretionary bonuses, incentives, and commissions, paid quarterly or more frequently, as part of the total annual salary for exempt-status determinations.
7. Rule: No change to the "Duties Test." Implications: None. Salaried workers who primarily perform executive, administrative, or professional duties continue to be exempt from DOL's overtime rules. DOL may move to alter the duties test in the future based on comments received during this notice and comment period.

These are just a few of the many pieces of Legislation that passes through Congress each session that gives the Federal Government the over reaching arm to have a say in the day to day business of the States' Public School Systems.
