## Conditions of Use:

### Non-Commercial Use:

- Non-commercial use applies to images intended for personal use or images intended for inclusion in publications such as books, magazines, newspapers, films, newsletters, newscasts etc.

### Commercial Use:

- Commercial use applies to images intended for resale or reproduction for advertising or on items for resale (ie. Framed images, postcards etc)
- Purchases of images for commercial use provides non-exclusive, onetime use for 1 year.
- Any subsequent use constitutes a reuse and must be applied for in writing. This includes use in a new project, edition or format as well as use in any promotional material.
- A reuse fee will be applied.

### Web Usage:

Digital reproductions intended for use online must be displayed at 96 DPI or lower.

### Credit:

A credit line, "Courtesy of Grimsby Historical Society" is mandatory and must be provided if material reproduced from the GHS collection is published for commercial or non-commercial purposes in print, on-line, or in other media. With printed matter, the credit line must appear on the same or facing page as the illustration. Crediting of each individual image is mandatory.

### Changes to original photograph:

No changes are permitted to the original photograph – including cropping, superimposing, printing on colour stock, tinting, bleed off the page, etc. The GHS reserves the right to examine proofs and captions for accuracy and sensitivity prior to publication with the right to revise, if necessary.

### General:

1. One complimentary copy of any published work, in which the photograph appears, is to be supplied to the Grimsby Historical Society.
2. Permission for reproduction is limited to the applicant and is non-transferable. You are not to permit others to reproduce the photographic copy or any facsimile of it.

3. In authorizing the publication of a photographic copy the GHS does not surrender its own right to publish it, or grant permission to others to do so.
4. The GHS reserves the right to restrict the number of photographic copies; to restrict the use of reproduction of rare or valuable material involving unusual difficulty in copying; and to charge a higher copying fee than specified.
5. The Society may in the event of unauthorized reproduction require the surrender of all materials containing such unauthorized reproductions, and the applicant agrees that such materials shall be immediately surrendered upon the receipt of a request from the GHS.
