

## TERMS AND CONDITIONS FOR ALL OUR PROGRAMS AND CLASSES

I hereby grant permission for my child to participate in the classes, enrichments, after school programs, camps, clubs and activities offered by TLCC/Tic-Talk Spanish, Maryland. In the event my child becomes ill or injured while participating in this activity. I hereby authorize and consent to the rendering of any reasonable emergency medical treatment due to the illness or injury stemming from my child's involvement in the activity. While the instructor and/or parent volunteer will make their best efforts to contact you or one of the emergency contacts you listed above, as quickly as possible, I understand, agree and consent to allow emergency medical treatment to be administered to my child as quickly as possible, regardless of whether I or any of my emergency contacts have been successfully contacted. It is your responsibility to pick up your child from the designated area at the designated end time unless other arrangements have been made.

- All enrollment fees must be paid in advance or by the first session.
- Late payments will be subject to a 10% administration fee.
- Children must be collected on time. We reserve the right to charge for late collection.
- We expect a courteous and polite behavior in our classes, clubs and camps. We reserve the right to exclude any child who shows inappropriate behavior.
- We reserve the right to substitute teachers should the need arise.
- No refund is paid for cancellation or in the event of stopping attendance during the course of the sessions.
- There is a \$25.00 fee on all returned checks.

We reserve the right to cancel any program due to inclement weather or low enrollment.
