The ***Manufacturing Technician Level 1*** course was developed to meet the booming employment demands of the manufacturing industry and can enhance your ability to begin a great career in advanced manufacturing.

By completing this training program, you will be prepared for entry-level positions with regional manufacturers making competitive wages, benefits and with opportunities for additional training and advancement.

Course content was developed in partnership with key industry employers and partners. You will learn a variety of skills relevant to manufacturing such as successful workplace standards and basic technical skills, including the ability to read a blueprint, perform common manufacturing math calculations and use common measurement instruments. Course study incorporates hands-on activities, online learning and discussions. Successful students will receive a CEU Certificate of Completion and a Certificate of Work Ethic Proficiency.

Is this career right for you?

Careers in advanced manufacturing offer exciting opportunities that include operating high-tech tools and machinery, analyzing problems, developing creative solutions, and working with your hands and mind.

Manufacturing technicians perform a wide variety of job duties that may include:

- *Operate precision machinery, systems and processes*
- *Work from blueprints*
- *Ensure quality production using tools such as micrometers*
- *Monitor and adjust production processes or equipment for quality and productivity*

Requirements include a high school diploma or GED certificate and the ability to pass a drug test. Successful candidates must be dependable and able to work effectively with others. Candidates also must meet minimum age requirements, which are 16 or 18, depending on employer.

Upon successful completion of the Manufacturing Technician Level 1 course, individuals will be guaranteed an interview with several regional manufacturing companies:



Today's manufacturing environments use high-tech equipment and provide diverse careers, including accounting, logistics, purchasing, human resources, engineering of various levels, quality control, manufacturing technicians, shipping and receiving, CNC machining and tool making, and building and machine maintenance. Many employers provide additional training and advancement opportunities.
