DO YOU KNOW?

Unlike human food chicken, pet food/animal feed chicken is allowed through the AAFCO legal definition to be sourced from condemned chicken; chicken that should be considered garbage. The same holds true for every single pet food ingredient – all meat, vegetables, fruits and grains. Pet food/animal feed ingredients are allowed through AAFCO legal definitions to be sourced from...no other way to phrase it...garbage. Some manufacturers use garbage chicken, others use food quality chicken. But consumers are not informed which is which. Regulations do not allow any pet food manufacturer to state quality of ingredient information (human grade or feed grade) on a pet food label.

OBEDIENCE CLASSIFICATION - For class descriptions, refer to AKC Obedience Regulations. Obedience entries will be arranged in ascending jump height order, starting with 4" in all classes where jumps are used.

NON-REGULAR CLASSES -- Brace • Veteran

AKC Obedience Regulations - Section 5 - *Brace Class* - The Brace class will be for two dogs of the same breed or two dogs listed with AKC Canine Partners of similar height at the withers that are eligible under these regulations and capable of performing the Novice exercises. The dogs need not be owned by the same person but will be handled by one handler. Dogs may be shown unattached or coupled (the coupling device will not be less than 6 inches in overall length). Whichever method is used will be continued throughout all exercises. A separate official entry form will be completed in full for each dog entered. Exercises, performances and judging will be as in the Novice class. The brace should work in unison at all times. Either or both dogs in a brace may be entered in another class or classes.

AKC Obedience Regulations - Section 6 - *Veterans Class* - The Veterans class will be for dogs that have an obedience title and are at least 7 years old on the date of the trial. The exercises will be performed and judged as in the Novice class. Dogs may be entered in another class or classes. At breed specialty trials, the minimum age requirement for the Veterans class may be set by the breed Parent Club, in which case the age will be stated in the premium list.

RALLY CLASSIFICATION - For class descriptions, refer to AKC Rally Regulations.

RALLY NON-REGULAR CLASSES –Pairs

Rally Pairs class consists of competition by one handler working two dogs at one time through a rally course at a level selected. Scores will be based on a possible 200 points, with ties being broken by time

MOVE UPS WILL BE ACCEPTED FOR BOTH RALLY AND OBEDIENCE – written move-up application must be submitted to the Superintendent at least 30 minutes prior to the start of the trial, not 30 minutes prior to the start of the class

Do You KNOW?

Here are a few 'garbage' ingredients listed in the AAFCO Official Publication (viewable to consumers at a cost of \$100.00 a year) that are all allowed ingredients in pet food/animal feed. (Found on Susan Thixton's website truthaboutpetfood.com)

- "Cereal Food Fines" bits and pieces of breakfast cereals.
- "Sugar Foods By-Product" basically ground candy.
- *"Food Processing Waste"* vegetable product wastes from the production of human food.
- "Fish Residue Meal" the residue remaining after the manufacture of glue.
- "Dried Meat Solubles" is the dried waste water of steam processed slaughtered animals.
- *"Hydrolyzed Poultry Feathers"* ground, processed feathers.
- *"Fleshings Hydrolysate"* chemically treated bits of animal flesh removed from hides.
- *"Hydrolyzed Hair"* chemically treated animal hair.
- *"Leather Hydrolysate"* liquid chromium tanned leather.
- *"Unborn Calf Carcasses"* self defined.
- "Used Cooking Oil, Feed Grade" used cooking oil recovered from restaurants.
- "Dried Poultry Waste" dried poultry poop.
- *"Dried Poultry Litter"* dried poultry poop and bedding.
- "Dried Ruminant Waste" dried cow, sheep, ect. poop.

NOTICE TO EXHIBITORS - ALL EVENTS



The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

- The American Kennel Club will collect: a \$3.00 Event Service Fee and \$.50 Recording Fee where applicable for the first entry of a dog, plus a \$3.00 service fee for each additional entry of the same dog in the regular and non-regular recordable single-entry classes, in all AKC licensed and member club events. At every licensed or member club rally trial, a recording fee of \$3.50 is required for the first entry of each dog and a recording fee of \$3.00 is required for each additional entry of collecting all Event Service Fees for The American Kennel Club. These event service and recording fees shall be forwarded to The American Kennel Club along with all other required event results within seven (7) days of the close of the event.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be
 accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement
 and Rules on reverse side are NOT ACCEPTABLE. The Club and/or TDCOPS Show Secretary assumes no responsibility for
 wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR
 COMPLETENESS OF ENTRY RESTS SOLELY WITH THE ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. TDCOPS will add a \$25.00 collection fee to the
 amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money
 order for the original amount PLUS the \$25.00 NSF fee. Subsequent returned checks from same person may result in their being
 put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed by the Club to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries. There is no refund for bitches in season in Obedience.

There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. The TDCOPS Show Secretary will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made.
