- If a sample is received in an inappropriate testing condition then the client will be informed immediately or as soon as is possible and repeat sample requested.
- The provider is not responsible for post and packaging of incoming samples to the laboratory and advice customers to follow packaging guidelines as per website. (www.animalhealthlabs.ie).
- The Provider uses a third party courier service. The Provider is not responsible for goods while in the possession of the courier company.
- An Urgent Testing Service is available for all samples, a fee will be charged for this service subject to times and dates results are requested for by the customer (minimum charge of €10.00). Please contact AHLI directly should you require use of this service.
- No verbal results will be given over the phone. All results will be available via online system via website, (fax, or email results will only be provided on written request by the client).
- The latest revision of test interpretations is available on your online secure login or upon request.
- Should the client request additional testing to a sample, then provided there is sufficient test sample available, additional testing will be carried out and the charge will be added per current price list.
- The provider may use any residual samples in the future for research purposes. All client information will remain confidential in such testing.
- Force Majeure, the provider is not liable for failure to perform its obligations if such failure is as a result of Acts of God (including fire, flood, storm, hurricane or other natural disaster), government sanction, blockage, embargo, labour dispute, strike, lockout or interruption or failure of electricity or telephone service and any other cause or causes similar or dissimilar to the above which cannot be controlled by either party.
