FAECAL SAMPLING GUIDELINES

- 1. Place 15-20 lambs in a clean pen. Leave them undisturbed for a couple of hours.
- 2. Using gloves, collect faecal samples from 10 fresh faecal deposits and place them in the 10 sample containers provided (you must collect at least a heaped teaspoonful size faecal sample from each faecal deposit).
- 3. Place all filled sample containers in the zip lock bag provided.
- 4. Post samples with this form on the day of sampling, or the following day at the latest. If samples are collected at the weekend store them in a cool place preferably in a fridge not used for domestic purposes. (DO NOT FREEZE OR PLACE IN DIRECT SUNLLIGHT) and post on Monday.

RESULTS OF FAECAL EGG COUNTS

- 1. Results will be reported to the email address which you have provided overleaf.
- 2. Please discuss your Faecal Egg Count results with your agricultural adviser/veterinary surgeon when drawing up an appropriate worm control programme.
- 3. Animal Health Laboratories will also report your faecal results and information provided overleaf to DAFM.
