Arrangements for spring launch MUST be made with the office at least 10 days in advance or your launch could be delayed. **NO BOAT WILL BE LAUNCHED UNTIL ALL BILLS HAVE BEEN PAID.** If you are not winter storing with us your boat must be removed from the premises by November 1, 2017 or you will be charged storage of \$20 per day. Our summer season begins May 1, 2017 and ends October 31, 2017. Water on the docks is only available during the season.

We **MUST HAVE A SET OF KEYS TO YOUR BOAT** in the office. In the event your boat must be moved and we do not have a set of keys, you will be CHARGED A \$75.00 tow fee.

This contract MUST BE SIGNED AND RETURNED WITH A 50% DEPOSIT BY **JANUARY 1, 2017 FOR US TO HOLD YOUR SLIP OF CHOICE.** Slips that do not have deposits to hold them will be made available first by waiting list requests, then to anyone. If you have an outstanding balance, any deposit made will first be applied to those balances. Deposits on slips are non-transferable and non-refundable. **Remaining slip balances are due on or before March 1, 2017.** If the balance is not paid by **March 1, 2017** we will no longer hold your requested slip nor guarantee you any slip.

**CURRENT PROOF OF INSURANCE IS REQUIRED BEFORE BOAT CAN OCCUPY SLIP**

**Electric Charges** – Electric meters are read at the beginning of the season when the slip is first occupied, mid July and end of season. Electric use will be billed when the balance reaches \$20 or at the end of the season, whichever comes first.

**Store Charges** – Lee’s Marina affords every customer with the opportunity to charge items purchased in their marine store to their customer account. These purchases will be billed quarterly or when the total is more than \$20. If your account is not paid in a timely manor, Lee’s Marina reserves the right end this privilege.

**If the sale** of your boat is started, promoted, or consummated while the boat is on the premises or within the compounds of Lee’s Marina, either ashore or afloat, the marina will receive the usual standard applicable brokerage commission of 10% if we are the broker, 5% if we are not. Boats will not be shown for or to other brokers unless prior arrangements have been made with the office. Any balance due Lee’s Marina, plus any commission fees must be made before boat leaves the marina.

**It is understood that** said Lee’s Marina is not responsible for any damage to persons or properties and without limiting the generality of the foregoing including fire, theft, vandalism, damage by hurricanes or storms, or by fellow renters or visitors to renters boat or car on said premises, slip, dock or facilities of Lee’s Marina. All damage should be covered by renters own insurance. Proof of insurance required prior to the start of the season.

**ONLY OWNERS** are permitted to work on their own boats while in storage on our premises. Outside contractors are permitted on the premises only for work that cannot be provided by Lee’s Marina or their subcontractors and only after arrangements have been made with the office for approval and a copy of contractors’ insurance has been submitted to the Lee’s Marina office from insurance agent.

**For the Safety & Enjoyment of Everyone:** No dock boxes or grills allowed on docks. Children must wear proper floatation devices and be accompanied by an adult. Loud, vulgar or rude behavior will not be tolerated. Proper footwear should be worn at all times.

**Account Balances** older than 30 days will be subject to finance charges of 2% per month.
