LIMITED REGISTRATION: Dog may not be bred or shown. Puppies come with limited registration unless otherwise requested. Dogs may be entered in performance events with limited registration.

FULL REGISTRATION: Dog may be bred and shown. We do not guarantee your puppy will be of breeding quality. We do not guarantee them in any way to be able to produce puppies.

SELLER RESPONSIBILITY: Every effort has been made to insure that your puppy is as healthy as possible. However, bulldogs are prone to multiple health problems that are breed related. The seller certifies that, upon receipt, the dog is in good health and has been immunized and wormed according to the accompanying health record of said Bulldog. Puppy will have received vaccinations and worming. No replacements will be given in case of Parvo. Puppies that have been injured or exposed to contagious canine diseases are not returnable. Puppies are guaranteed for one year from the date of purchase. If a puppy is found to have a problem that warrants its return, the buyers vet must send a certified letter that's signed and dated with the said non treatable defects/illness, buyer must not give us the letter doing so will jeopardize the return of the puppy and possibly void the health contract. The letter must include the vet's name, address and telephone number. No cash refunds are given for returned puppies for any reason. Sellers guarantee will only cover the heart. If the dog dies within a 1 year time frame, the buyer must pay to have the animal autopsied to determine the reason. The seller reserves the right to a second veterinarian opinion at the expense of the seller. Shipping puppy back is at the buyer's expense. If the reason is found to be one of the above listed conditions, the Seller will replace the puppy from another litter of equal value, same sex, and color if possible when available. The seller does not guarantee size, coat, color, un-descended testicle, skin issues, eye problems or fertility or anything that is common to the bully breeds once the puppy has left our premises. We do not warranty umbilical hernia, conccidiosis, giardia, ear mites, external/internal parasites, viral or bacterial infections that may occur after the puppy is brought into your environment. Seller may use puppies and your pictures as advertising on their website and social media networking pages.

BUYER RESPONSIBILITY: Buyer agrees to house the bulldog puppy appropriately in a clean, climate controlled environment, provide vaccinations, worming, heart worm prevention, proper socialization, vet care, food and fresh water. The buyer agrees if the puppy has sustained health problems resulting from injury or mistreatment or neglect after leaving the Seller, the Seller will not assume responsibility for it and no refund will be forthcoming. There may be exceptions, to be determined by the seller. If abuse or neglect is found to be the case, seller may demand the puppy be returned at the return of the buyers expense. The buyer agrees to take good care of this dog, feed and house the dog properly, maintain shots, and control the dog on a harness when in public. The Buyer has forty eight hours to take puppy to their vet to be examined after date of purchase or contract is void. Buyer agrees to accept responsibility for breed related problems that are not life threatening and are easily treatable. These problems include, but are not limited to: Cherry eye, entropion or ectropion, stenotic nares, skin allergy, localized demodex , elongated soft palate, stenotic nares, over-heating or heat exhaustion. **REMEMBER that a Bulldog can over heat quickly and easily and may die as a result of overheating. Your Bulldog must be an indoor dog.** This dog is not to be used for any type of puppy mill, dog farm or other mass producing or operation. Payment in full must be made prior to you taking ownership of the dog; payment is in cash or money order

This guarantee applies to the original buyer only, and cannot be transferred to a second buyer or owner. Any disputes must be handled in the state of Kentucky at buyer(s) expense. Any changes to this contract must be in writing and agreed to and signed by both parties. Buyer agrees NOT to sell this dog to any retail company or establishment. This contract is legal and may be enforced by legal means at the buyer's expense and all disputes must be settled in Kentucky in the county in which the seller resides. This dog is sold to you as a pet only and nothing further.

A deposit of \$500.00 is required unless otherwise stated. Buyer understands that the deposit is to reserve puppy until puppy is ready to go to his/her home. Deposit will be deducted from the total purchase price. All deposits are non-refundable, unless in the event that puppy passes before purchase is complete. In said event buyer can pick another puppy of the same sex, or deposit will be refunded.

The buyer(s) agree never to abandon, or surrender the dog to an animal shelter, rescue group or other similar facility, without at least first attempting to contact the seller/breeder to make other arrangements for the dog.
