## Region 17 Select Stallion Service Auction and Futurity

### Mare Requirements:

1. Mare Owners are required to complete the Mare Nomination Form by the advertised deadline of the year bred and to submit with the mare nomination fees as follows:

PURCHASER of breeding - The mare owner who purchases the auction breeding is entitled to the discounted mare nomination fee of \$100.

STALLION OWNER - The stallion owner of a SOLD BREEDING is entitled to ONE discounted mare nomination fee of \$100.

\*\*\* NEW \*\*\*

BUY IN NOMINATIONS - all other eligible foals (purebred and part-bred Arabian offspring sired by a stallion whose breeding has SOLD in the same breeding year) may buy into the futurity for a \$150 Mare Nomination Fee. This includes non auction breeding's, as well as additional stallion owner breeding's.

2. Mares will be nominated for one (1) breeding year.

3. Only (1) Mare Nomination for each auction breeding may be submitted. Embryo Transfer (ET) Mare Nominations are required to designate the recipient mare by the advertised deadline of the breeding year.

4. The Mare Owner is responsible for compliance with the requirements as set forth in the breeding contract including, but not limited to health papers, vaccinations, normal mare care fees, artificial insemination fees, collection, and shipping charges.

### Breeding's:

1. Foals that result from breeding's to any stallion bought in the Auction with mare nominations completed by deadline will be eligible to come back as yearlings to compete in halter and as 5-year-olds to compete in one of 10 performance classes (Western Pleasure, Hunter Pleasure, Country English Pleasure, Sport Horse under Saddle and Reining).

2. The R17 SSAF purchased breeding must be used in the breeding season immediately following the Auction and may NOT be carried over to another year for purposes of R17 SSAF futurity eligibility.

3. In the event that the mare re-absorbs or aborts, or the foal dies, etc., any resulting foal from a rebreeding in another year will not be eligible for the futurity and the Mare Nomination fee will NOT be refunded.

4. Foals from resulting breeding's must be registered purebred or part-bred Arabian to be eligible for the futurity. Stallion owners do have the option of allowing breeding's to be sold to mares who will not produce eligible foals. (for example, a half-arabian or non arabian stallion bred to a half-arabian or non arabian mare.) In this case the funds from the breeding purchased are still added to the futurity pot but said foal will not be eligible to win. The Stallion owner will still receive ONE reduced rate mare nomination for themselves, and all purebred and part-bred foals sired by that stallion in that breeding year will be eligible buy into the futurity for the buy-in nomination rate.
