

The Savvy Mom Sale accepts just about ANYTHING related to babies and kids!

ITEM CONDITION: Clothing items must be in great condition with little-to-no signs of wear, free of strong odors and any damage, such as stains, tears, holes, missing buttons, or dysfunctional zippers. Only items applicable to the upcoming season will be accepted. Equipment and toys should be clean, include all pieces, and must not be recalled.

ITEM INSPECTION: During Savvy Mom Sale drop-offs, all clothing and shoes will be inspected, and any unacceptable items will be sent home with the consignor. We want to be known for having the best quality merchandise and we want you as a purchaser to have confidence that you are buying the best at Savvy Mom Sale. Your items will be thoroughly inspected so please don't be offended if we ask you to take back some of your items.

REGARDING RECALLS: It is the CONSIGNOR'S RESPONSIBILITY, as seller of the items, to make sure none of their items have been recalled. This is listed in our online Seller Agreement, which is required for all participants to agree to in order to consign with our sale. Below you will find specifics on what items will be accepted.

<ul style="list-style-type: none"> • LIMITS: Consignors can bring up to 250 items, with a minimum of 20 items. • Volunteering will increase this limit: 1 shift Volunteers up to 350 items 2 shift Volunteers up to 450 items. Maximum of 450 items. • Ladies' & Teen Boy Shoes: 10 pairs per consignor CHILDREN'S CLOTHING: Up to a size child's 20. Must be appropriate for the upcoming season. TEEN CLOTHING: We will accept all sizes, as long as they are high-demand brand names, such as: Abercrombie, Aeropostale, American Eagle, Hollister, Miss Me, Nike, Under Armour & other athletic brands. • We do not have dressing rooms, so bring waist/length measurements and a measuring tape, if you need them! Lastly, please price reasonably (25-40% of retail for used, 50% or less for new w/ tags). Our shoppers are looking for great deals! • MATERNITY CLOTHING: <ul style="list-style-type: none"> o Must be current style in excellent condition. o Should be priced no more than 25% of retail, except for designer or high-end brands, which may be priced a bit higher. o Please consider discounting ALL of your maternity clothing! <p>SHOES: All children's sizes, as well as women's and men's sizes, but all shoes MUST be style- appropriate for a pre-teen! (limit of 10 pairs per consignor - multiple pairs may be priced together and counted as one)</p>	<ul style="list-style-type: none"> • We do not accept items with stains, tears, holes, broken zippers, missing buttons, or items showing excessive wear (extremely thinned knees, balled fabric, etc). • We do not accept underwear. We do not accept onesies or other clothing in Ziploc bags (all onesies, etc. must be on hangers) • No women's/men's clothing (except for maternity clothing) • No recalled clothing (if you are consigning clothing with drawstrings made for children under age 12, make sure that they have not been recalled. Also pay close attention to recalls on pajamas that do not meet fire retardant standards!)

<ul style="list-style-type: none"> • CLOTHING ACCESSORIES: Hats, hair bows, belts, ties, bloomers/diaper covers, backpacks, and child purses • SEASONAL-SPECIFIC ITEMS: For more specifics on what clothing items are accepted at spring/summer and fall/winter sales, please scroll to the bottom of this page. • RECALLS: Please ensure none of your clothing items have been recalled by visiting the Consumer Protection Safety Commission's website and choosing "Clothing (Children)". Note that clothing with drawstrings that is made for children under age 12 is now deemed unsafe and is most likely recalled.

BABY EQUIPMENT & CHILD FURNITURE

<ul style="list-style-type: none"> • BABY EQUIPMENT: Strollers, joggers, bike trailers, car seats, pack-n-plays, baby swings, jumperoos, walkers, high-chairs, booster seats, exer-saucers, bouncy seats, doorway jumpers • CHILD FURNITURE: Cribs, toddler beds, bassinets, mattresses, changing tables, rocking chairs / gliders, toy boxes, bookshelves, other children's furniture. NOTE ABOUT <u>CRIBS</u>: To comply with crib laws, we will no longer accept cribs manufactured before June 28, 2011. Consigned cribs must either: A) Have the manufacture date on the crib, showing it to be manufactured on or after June 28th, 2011, or B) Have a Certificate of Compliance from the company which manufactured the crib stating that the crib is certified to meet laws 16 CFR 1219 or 16 CFR 1220. Thank you for your understanding as we seek to make the safety of our children priority! • Equipment must be clean. • Attach any accompanying small items securely. • NOTE: Sellers are responsible for assembling all cribs, beds, pack-n-plays and playpens they bring during drop-offs. • If you intend to sell a CRIB, PLAYPEN, PACK-NPLAY, CAR SEAT, BATH SEAT, BABY WALKER, MATTRESS, OR BUNK BEDS, please ensure your item meets the requirements listed on the CPSC website. 	<ul style="list-style-type: none"> • No dirty or broken equipment. • No equipment with missing seat-straps. • No recalled or unsafe items • No carseats that were manufactured more than 5 years ago (exception made for those having a future expiration date imprinted on them), and none that have been in a wreck or are missing straps.

<ul style="list-style-type: none"> -Short-sleeved and 3/4-length sleeved tops (unless they have fall/winter detail - pumpkins, snowflakes, etc.) -Limited amount of long-sleeved infant clothing (only if light or pastel colored or spring/summer detail) -Boys' long-sleeved, dress shirts (only if light or pastel colors) -All sizes of light-weight cotton, 1-piece sleepers. Footed is fine, but fleece and other thicker materials must wait for fall, as well as those with fall/winter details (pumpkins, snowflakes, etc). -Shorts, Capris, & Pants (no winter fabrics - see fabrics listed on right) -Light-weight sweaters (only if light colored) -Light-weight wind jackets, rain jackets -Leotards and dancewear -Swimwear & coverups 	<ul style="list-style-type: none"> -L/S tops (unless they have Spring or summer detail - beach scenes, etc. -Winter fabrics (corduroy, velvet, fleece, suede, sweatpant material, etc.) -Black, patent dress shoes -Halloween costumes -Coats, hats, gloves, mittens - Winter boots, ski boots (cowboy boots and rain boots ARE accepted)

<ul style="list-style-type: none"> -Long-sleeved and 3/4-length sleeved tops (unless they have spring/summer detail, beach scenes, etc.) -Short-sleeved camo clothing, football jerseys or other athletic-wear (including dri-fit shirts & Razorback/UA/AU/etc onesies/shirts/dresses) -Short-sleeved BOYS' <u>Collared</u> Polo & Dress Shirts (only dark colors for fall/winter, or white for school uniforms) -Capri pants (unless they are light or pastel colored, which is more suitable for Spring/Summer) -Pants, including jeans, khakis & sweatpants -Heavy Coats and jackets, mittens, & winter hats, hoodies -Halloween costumes -Leotards and dancewear -Winter Fabrics: sweaters, fleece, corduroy, velour, velvet, suede 	<ul style="list-style-type: none"> -Short-sleeved tops (unless they have fall/winter detail - Fall, Halloween, Thanksgiving Christmas, etc.) -Short-sleeved infant clothing -Shorts and skorts -Short skirts (unless winter fabric or dark colored) -Swimwear or cover-ups -Life jackets -Sandals or open-toed shoes -White dress shoes -Crocs shoes (except for lined styles)
