• Judy is certified by the National Quilting Association (NQA) and the National Association of Certified Quilt Judges (NACQJ), and has judged more than 7,500 quilts on a



How to make a quilt sleeve

early all quilt shows require a 4" hanging sleeve for quilts exhibited. This 4" size accommodates most hanging rods or slats used at shows.

Here are some basic directions.

Measure the top edge of your quilt, where the sleeve will go, about ¹/₂" from the top. In this example, the quilt measures 13". **See photo A**.

2 Cut a strip that is 9" wide and the width of your quilt plus 1" (for the quilt shown here, this is a rectangle 9" x 14").

3 Fold in the short ends ½" and press. Fold in again ½" and press. This eliminates the raw edge. **See photo B.**


4 Sew a seam along these short ends. See photo C.

5 Fold the strip in half with the wrong sides together, and press.

NOTE: By using this method, you do not have to turn the tube inside out after you sew it together. If you have a wide quilt, and a long sleeve tube, it can be difficult to turn it right side out. This way, the seam is hidden between the sleeve and the quilt backing.

5 Stitch a ½" seam along the long edge. See photo D.




7 Press the seam open, center it, and press. See photo E.

Along one of the long edges, fold down and press about ¼". **See photo** F. This allows for a little slack so the quilt will hang better on a rod or slat. Without this slack on the back, you may have a bulge on the front of the quilt where the hanging rod goes through. You can see this slack more clearly on the side view (photo G).

Pin the sleeve to the back of the quilt, about ½" from the top. See photo G. Take care to place the sleeve low enough that it will not show from the front once the rod is inside and the weight of the quilt pulls the sleeve up toward the top of the quilt. This is even more of an issue if the quilt is uneven at the top, such as the example shown here.

10 Hand-stitch the sleeve to the quilt. **See photo H.** Go around all four edges, even the short sides. Your stitches should only go through the backing and the batting. You should not see them on the front of the quilt.



<u>Coastal Prairie Quilt Guild</u> <u>Minutes of the May 3, 2016 Board Meeting</u> (approved at the June 7, 2016 board meeting)

The meeting was called to order by Barbara Wall, President, at 1:30 p.m. at the Keegan's Woods Community Building.

Board members in attendance: Barbara Wall, Helen Wilems, Barbara Elliott, Katherine Onstott, Martha Baldwin, Pauline Manes, Susie Doe, Lisa Patterson and Jennifer Pazicni. A quorum was present. Committee members in attendance: Julie Dayton, Judy Wolter, Carol Ann Barley and Sally Staner.

The Minutes of the April 5, 2016 Board Meeting were approved as presented.

The Treasurer's Report for April (reporting through May 1, 2016) was approved with one correction to be made; Retreat Income is to be categorized to reflect \$3475 for Fall Retreat and \$3300 for Spring Retreat.

OLD BUSINESS

- **Board Elections/Nominating Committee --** The Nominating Committee was duly elected at the general meeting on April 19th. Susie Doe will serve as board representative; the other members of the committee are Diane Aleman, Rita Evans, Kay Paul, and Rebecca Trevino. Barbara Wall indicated that she had approached Rebecca about being the committee chair, but has not yet received a response.
- **Shop Hop** Barbara Wall reported for Sandi Pedersen that the contract with the bus company has been signed. Currently we expect to use a 35-passenger bus. At the \$35 shop fee 33 participates are needed to break even. In order to contract for a 50-seater bus we would need a minimum of 38 participants. It was recommended that once 35 participants sign up, there will be a waitlist implemented and if we get 4 additional registrants we will upgrade to a larger bus.
- **New Member Welcome** The New Member Welcome scheduled for April 13th was cancelled due to lack of interest. It will be left to the new board to decide whether to schedule another such orientation session.

NEW BUSINESS

Retreats -

- It was reported by Barb Wall that participants at the Spring Retreat at the Jordan Ranch had a wonderful time. A new chef on staff there did an excellent job and all participants enjoyed their stay and their quilting experience.
- Sally Staner reported that a deposit has been placed with Magnolia Manor for the Fall Retreat to be held on September 26th-29th. The cost will be \$270 for the retreat beginning at 2 pm on Monday and ending at 2 pm on Thursday. If no one else is booked in before us, we may arrange to arrive earlier on the Monday. The cost will also cover three meals per day on Tuesday & Wednesday, with dinner on Monday, and breakfast and lunch on Thursday. The retreat center requires a minimum of 12 participants and can hold a maximum of 24. A notice will be sent out in the June newsletter announcing the beginning a registration which will be on a first check, first serve basis. Sally also reported that she has scheduled our Spring Retreat 2017 with Jordan Ranch.

Quilt Festival Guild Quilt Showcase -- A member brought it to the attention of the board that the IQA Quilt Festival has an exhibit entitled Texas Quilt Guild Showcase. Anyone who belongs to a quilt guild and has won a ribbon for a traditional quilt at that guild's quilt show may submit an entry application for this special exhibit; the entry deadline is July 1st through the IQA website.

This exhibit will be announced at the next general meetings and an article will be placed in the newsletter.

BOARD REPORTS

President-Elect – Helen Wilems

There are no donation quilts from other guilds scheduled to be shown at the May meetings. Helen announced that Barb has chosen her President's block, a 6" split nine-patch block using red, white, blue and gold fabrics.

Membership – Barbara Elliott

Since the last board meeting there have been no new or returning members. Barbara and Pauline have been working on revising the membership application form for 2016-17. The recommended shortening of the form to eliminate the questions about interests was agreeable to the board. Membership renewals for 2016-17 will begin at the next meeting; renewals should be in by September 1st.

Programs – Katherine Onstott

May's night meeting will consist of a member Schoolhouse with 6-7 stations. Everyone can choose up to 3-4 stations during the 3-4 rotations. There will also be a Swap Table for those wishing to bring items to exchange. The day meeting on May 19 will feature Jan Matthews discussing "Paper Piecing".

Workshop Chairman – Martha Baldwin

The workshop this month is a \$35 class on paper piecing taught by Jan Matthews, a certified Judy Niemeyer instructor. At this time 6 members have signed up for the workshop.

Treasurer – Pauline Manes Nothing to report.

Secretary – Susie Doe

Susie mentioned that she would be unavailable to take minutes at the scheduled July board meeting as she will be on vacation. Many other members of the board realized that they would also be unavailable. As a quorum would be unrealizable on July 5th, the board voted to reschedule the board meeting for June 28th at the Keegan's Wood Community Center.

Representative-at-Large - Barbara Young

The proposed changes to the Bylaws will be voted on at the May general meeting.

Editor/Advertising – Jennifer Pazicni Nothing to report.

Program Chair-Elect – Lisa Patterson

Lisa reported that she has not yet received all of the speaker contracts for the 2016-17 year. Lisa asked whether we should cancel or postpone a booking with Nannette Holmburg for the August 2017 night meeting as she has been unable to find another organization to partner with to mitigate the high workshop fee. The board agreed that we should cancel this engagement. Lisa will attempt to secure another board-approved speaker for this date.

Workshop Chair-Elect – Debbie Garner (absent) No Report.

QUILT SHOW

Julie Dayton reported that Allison Etzler, Vendor Coordinator, has filled 42 available booths with 33 vendors. The On-Line Auction will be featured in the Show Program; a few pages will include a thumbnail of each quilt, a short description, and a link to the auction site. Julie reported that it was important for the guild to promote the show well to attract lots of attendees. Several expenses have gone up since the last show, including insurance coverage, pipe and drape, electricity. For the 2018 show

the rental cost at the Stafford Center is expected to increase, so the next show committee may need to consider a change of venue. The next full Quilt Show Committee Meeting will be held at the Sugar Land UH Library on Tuesday, May 17th at 6:30 pm.

COMMITTEE REPORTS
