- \*No smoking on grounds.
- \*Management & the judges decisions are final!
- \*Classes many be combined, split or cancelled.
- \*Refunds with veterinarian's or doctor's slip.
- \*Boots, long sleeves, & long pants required.
- \*No cross entry between leadline & other divisions.
- \*No cross entry between 10 & under and any canter class.
- \*Youth entering 13 & under classes cannot enter 10 & under classes regardless.
- \*ASTM/SEI approved helmets suggested and welcome for all riders.
- \*Novice Rider or Horse: Not to of won more than 3 blue ribbons in that division.
- \*Pony Classes open to pony breeds only!
- \*Junior Horse: 5 yrs & younger
- \*Senior Horse: 6 yrs. & older
- \*Any horse or rider deemed out of control will be excused.

- \*High Points are counted on horse/rider combo except leadline is counted on rider only.
- \*Series Hi-Point Trophy Buckles will be awarded to High Point & Reserve: 10 & under, 13 & under, 14-17, & 18 & over. \*Must participate in both shows to qualify.

- \***18 & over:** 15, 23, 24, 31, 35, 38, 39/40, 45, 46, 53, 57, 60, 61/62
