I understand that it is a criminal offense to give an exemption certificate to the seller for taxable items that I know, at the time of purchase, will be used in a manner other than that expressed in this certificate and, depending on the amount of tax evaded, the offense may range from a Class C misdemeanor to a felony of the second degree.

RENTAL POLICY

Commando Lighting and Grip LLC, is a lighting and grip equipment rental business owned and operated by Dallas gaffer Darrel Tawney. It includes a three ton grip truck, van with interview package, and addition inventory for daily rental.

A customer may rent the truck or van and use Darrel as your gaffer, or you may use your own. Outside Drivers must be approved by Commando Lighting and Grip. All Gaffers, Grips and Drivers bill as individuals and are not part of the equipment rental.

- Customer must have proof of insurance on file 24 hours prior to rental.
- Customer must confirm rental 48 hours prior to rental.
- Customer must provide Credit Card information for billing.
- Customer must sign Rental Policy agreement 24 hour prior to rental.
- Customer needs to sign and have on file a Sales Tax Exemption form.

Texas tax code Section 151.3185 states that equipment rented and used directly in the production of a motion picture or video is exempt from sales tax. The law requires us to have a signed form on file. No Texas sales tax number is required.

- Equipment rented per day basis with a minimum of one day.
- First time customers must pay rental bill at the end of the job.
- Customers with established credit rental balance is due net 30 days.

I _____ of _____, have read and understand all items in the rental policy. In addition, agree to pay for all loss, damage, and rental loss due to equipment damage or loss.
