The SSPC C-5 Supervisor/Competent Person Training for Deleading of Industrial Structures Refresher course includes the following:

1. Background information on health hazards of lead and other toxic materials
2. Worker protection from lead and other toxic metals
3. Regulatory update
4. Construction safety concerns
5. Control of environmental releases

Each participant receives a course manual. A 25 question, multiple-choice examination is administered at the end of the course. To receive a certificate and/or 0.8 Continuing Education Units from SSPC, students must attend all eight hours of the course and attain a 70% or better score on the exam.

SSPC indicates that successful completion of the C-5 course meets the competent person refresher training requirements for SSPC QP-2 Contractor Certification. It should be noted that this offering does not meet any state-specific refresher training requirements.
