The SSPC C-3 course was substantially revised in 2016! C3 contains specific discussions on protecting workers, compliance with environmental regulations, proper management of waste streams and operations that result in potential exposures to lead and other hazards, and associated control technology. It includes background information on the hazards of lead and other toxic metals as well as a review of the current legal and regulatory issues. The course also addresses developing programs to effectively control risks to workers, the public, and the environment.

- In-Process and Post-Competent Person (CP) Responsibilities/Demobilization

Most lectures/discussions are complimented with show-and-tell demonstrations. Hands-on workshops follow most units and reinforce the key points and test the knowledge gained through skill evaluations. Brief daily homework assignments reinforce key concepts and helps students prepare for the 100-question multiple-choice examination. To receive a certificate and/or 3.0 CEUs from SSPC, students must attend all 32 hours of the course and attain a 70% or better score on the exam.
