- Speed limit 15mph on 348th Ave.
- All dogs currently under the care of a veterinarian for a medical or surgical condition, and all dogs 10 years or over, will require a veterinary consent form prior to swimming.
- Dogs should be current on vaccinations unless medically excused.
- Keep your dog on a leash going to and from your car.
- Do not feed your dog within 4 hours of swimming.
- Doggy waste bags are provided so please pick up after your dog and discard the bag in the designated trash can. Dogs also often have to take potty breaks during their swim times. In the event your dog has a bowel movement in the pool, we reserve the right to charge a fee of \$200 if the pool must be shut down due to clean up.
- You will have 10 minutes in addition to your scheduled swim time to rinse and dry your dog, change, pay, schedule another appointment, etc.
- If dog is excessively dirty, they must be rinsed/brushed prior to entering pool
- Payment is due at the time of the session. We accept cash, checks, and all major credit cards .

#### CANCELLATION POLICY

When you schedule a swim appointment for your dog we reserve that time just for you. Therefore we require a minimum of 24-hours notice if you cancel your session, otherwise you will be charged for your reserved pool time.
