

The driver of Unit 2 gave I/O conflicting information multiple times throughout my investigation. Unit 2's original explanation of events was not consistent with the damage to either vehicle.

There was no debris in the roadway and no third party witnesses to the crash. The driver of Unit 1 was unaware of Unit 2's location prior to the collision.

The location of the damage to both vehicles would be consistent to Unit 2 making a left turn from Haymaker Pkwy (eastbound) onto S. Water St. There is no way to determine if either Unit had a "green arrow" or solid green light. Therefore, there is no way to the "at fault" driver in the collision.
