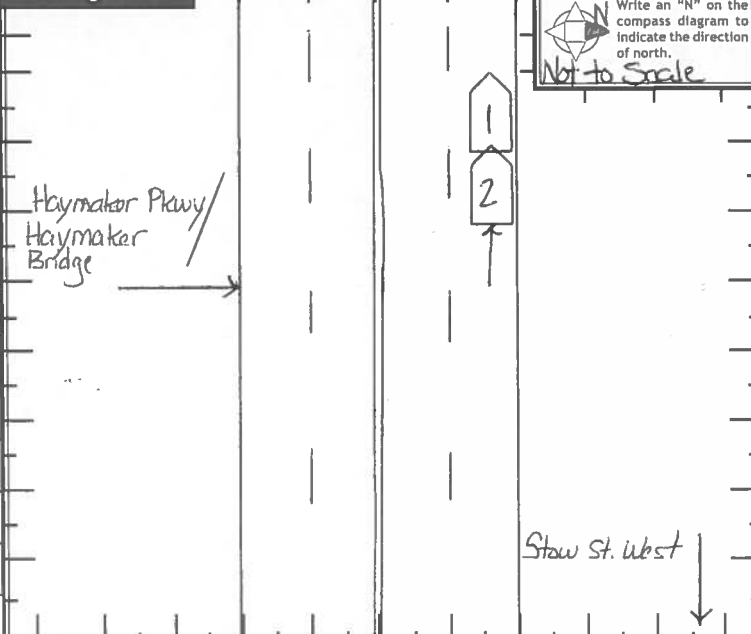

Unit #1 was traveling westbound on Haymaker Pkwy. in the curb lane. Unit #2 was traveling westbound on Haymaker Pkwy. directly behind Unit #1. The driver of Unit #2 failed to maintain an assured clear distance ahead of their vehicle and struck/rear-ended Unit #1.
