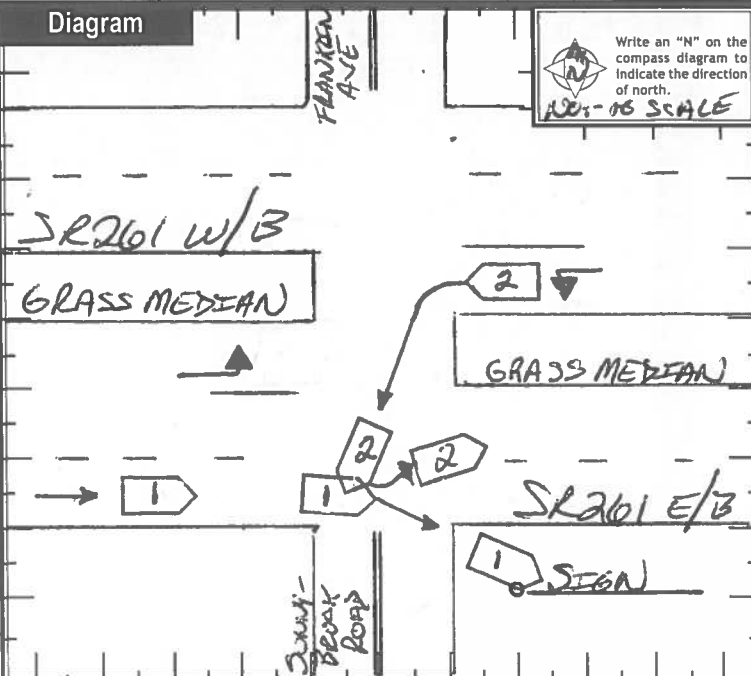

UNIT ONE WAS TRAVELING EAST ON SR261 APPROACHING SUNNYBROOK RD. UNIT TWO WAS TRAVELING WEST ON SR261 AND ATTEMPTED TO TURN SOUTH ONTO SUNNYBROOK. UNIT TWO FAILED TO YIELD TO UNIT ONE. THE IMPACT CAUSED UNIT ONE TO LEAVE THE ROADWAY AND UNIT TWO SPUN APPROXIMATELY 180 DEGREES.




