DESCRIBE HOW ACCIDENT OCCURRED While backing out of a parking space, Unit #2 struck Unit #1, causing damage to both vehicles. Unit #1 was unoccupied at the time of the accident. Unit #2 fled the scene and never reported the accident. A witness, who did not leave their name or contact info, left a note on Unit #1 stating they observed a blue Honda Fit strike Unit #1 and leave the scene. I located a blue Honda Fit with fresh damage in the parking lot at University Oaks. I located the driver of this vehicle who stated she struck Unit #1 while backing out of a space near building K and did not report the incident because she was late for a meeting/appointment. Over 48 hours had passed when I made contact with the driver of Unit #2 and she had made no effort to report.
