Unit 1 was EB on SR 261 stopped at the red light for S. Water St. Unit 2 was WB on SR 261 in the left turn lane for S Water St. The driver of unit 2 stated she had a green turn arrow that turned yellow when she turned left onto S Water St. She was struck in the right side by Unit 1 in the intersection. The driver of Unit 1 stated she was stopped and began through the intersection when the light turned green and struck Unit 2 who had turned in front of her. There were no independent witnesses.

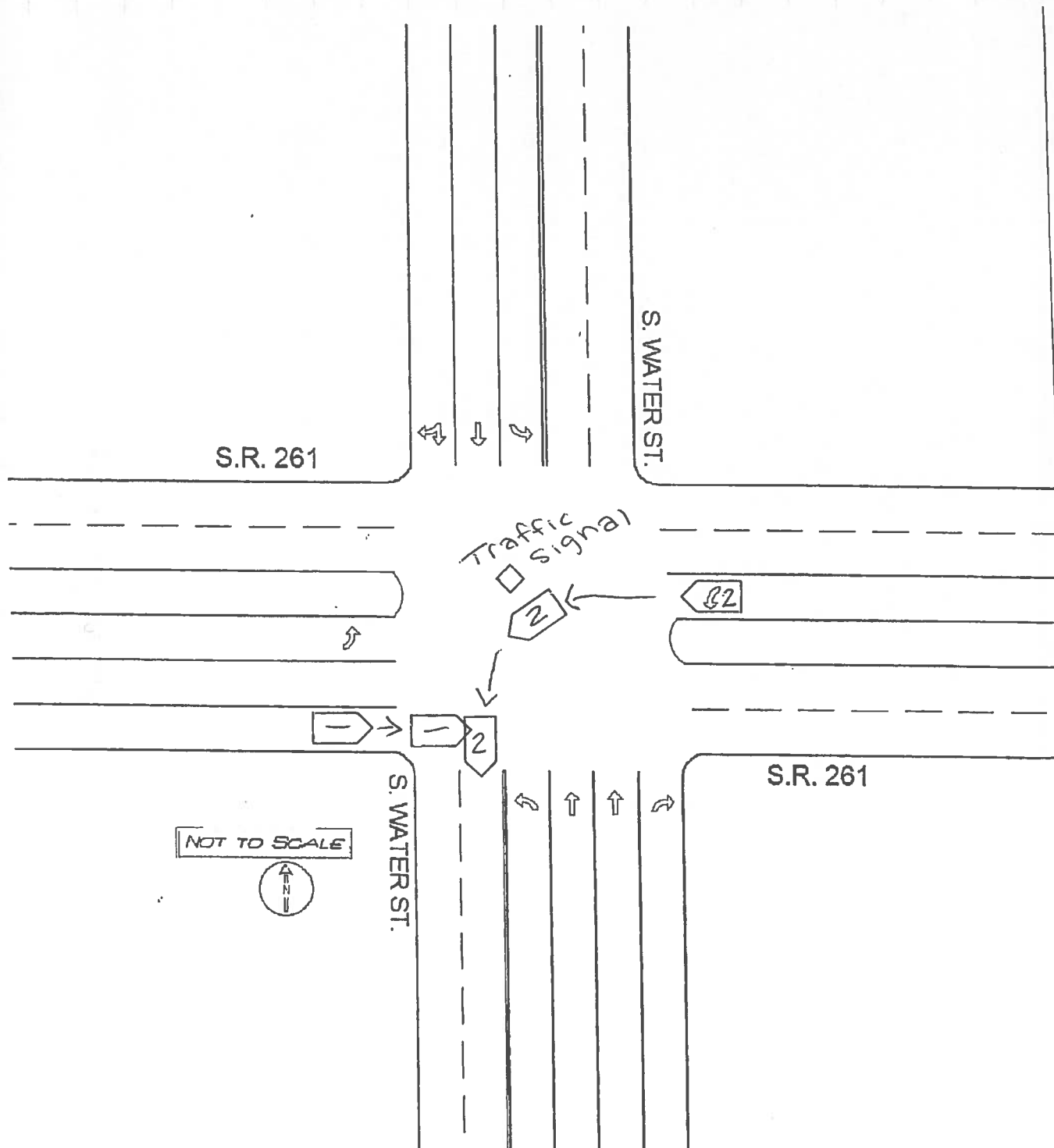
