
NARRATIVE Unit #1 was stopped in the eastbound left turn lane (to Acme) on E. Main St. Unit #2 was traveling eastbound on E. Main St. in the center lane (with a flat tire). Unit #2 went into the left turn lane and struck Unit #1. Unit #2 then fled the scene. A plate number for Unit #2 was obtained by a witness who did not want to be identified.
