Space Assignment

Exhibitor spaces are assigned by the Exhibit Coordinator based on a first come, first served basis. You may request a specific exhibit space; however, if that space is not available you will be assigned based on availability. Spaces will be marked during the fair. Requests for additional set up and tear down time must be made in writing to the Exhibit Coordinator. We require that Exhibitors purchase the event long option if there is a need to build a booth. Fire codes prohibit Exhibit spaces from exceeding their sizes and will be strictly enforced. Vendors who occupy more space than allowed will be charged for an additional space or asked to vacate the fair/market grounds.

Submitting Your Application

Application can be mailed to the address listed on page one (1) or dropped off at the fair office located on the fair grounds. If you are mailing your application, please allow seven (7) days for receipt. The Exhibit Coordinator will contact you to confirm your entry and assign a number within two (2) weeks of receiving the application and payment.

Hours

The Exhibit Hall will be open 8:00 a.m. to 8:00 p.m. and the fairground will be open 8:00 A.M. to 10:00 P.M. Thursday October 4 through Sunday October 7, 2018.

Identification and Security

Exhibitors will be given a maximum of two (2) Exhibitor Passes and one (1) vehicle parking pass. Additional passes can be purchased from the fair office. The full names of all Exhibitor participants must be submitted with this application. For Security purposes all participants must have proper Organization Identification and dress attire (e.g. company badge, uniform/dress attire), where applicable, and a valid Exhibitor Pass.

Cancellation

All cancellation requests must be made in writing by the Exhibitor Point of <u>Contact no later than 5:00</u> <u>P.M. Thursday, September 20, 2018.</u> Requests made through a third party or other officials will not be honored. <u>Cancellations AFTER September 21, 2018, will not be refunded.</u> Refunds will be mailed to the address on the Vendor Application and made payable to the individual/organization listed on the application. Please allow 20 business days after October 7, 2018, to process your refund.
