

Minutes of Idaho's first Al-Anon Meeting To OCGAN 12E

Date: November 4, 1972

Place: Twin Falls, Idaho

Time: 3:45 P.M.

Temporary Chairman: Betty T. [redacted] - Boise

Group Representatives Present: Betty T. [redacted] - Boise, Hildur Ne [redacted] - Boise  
Carol-Nampa, Phyllis L. - Boise, Betty C. - Twin Falls, Darlene-Idaho  
Falls, Evelyn-Pocatello & [redacted], Wendell.

Meeting called by Betty T. ----- Discussed whether to break up into  
Districts. Moved and Seconded not to have Districts at this time.  
By a vote of hands it was passed by a majority vote---none not in  
favor.

Election of Idaho Delegate:

Letters were sent to all Groups for name of Representative, prior to  
this meeting and letters were returned to Temporary chairman. Letters  
also asked for those who would accept if nominated for Delegate. These  
names have been placed on a ballot and I added at this meeting. Names on  
Ballot are: Betty C. [redacted], Evelyn W. [redacted], Darlene P. [redacted], Betty  
T. [redacted]. The four nominees were asked to tell about themselves and they  
all spoke about five minutes each. It was decided as in the handbook  
that it would require a 2/3 majority vote to win.

Ballots passed and the G.R.'s cast their votes and Billie O from  
Boise picked up ballots and were counted by Billie O. and Kathy B.  
Ballots were saved and given in package to New chairman.

It was decided by majority that if one person should get a 2/3  
majority vote the second person with most votes would be offered  
alternate Delegate.

Kathy B reported 2/3 majority vote for Betty T. [redacted] and second  
was Betty C. [redacted].

Betty T. [redacted] accepted as Idaho's 1st Delegate and Betty C. [redacted]  
accepted as Alternate Delegate. Betty T. [redacted] understands as the new  
Delegate she no longer has a vote and that her Wednesday nite Boise  
Group will be informed to elect a new G.R.

Nominations for Chairman:

Hildur N. [redacted], Boise was nominated by Beverly, Boise. Hildur  
declined saying Boise had the Delegate and other Twons should have  
the Officers.

Hildur N. Nominated Darlene, [redacted], Idaho Falls - No other  
nominations. By a raise of hands Darlene was elected by a majority vote,  
none not in favor.

The temporary chairman - Betty T. turned material over to New  
chairman and the new chairman asked if Betty T. would finish the elections.

Nominations for Secretary:

Betty C., Twin Falls nominated Evelyn W. [redacted], Pocatello. No other  
nominations. By a vote of hands she was elected by a majority vote,  
none not in favor.

Lou, Utah Delegate helped us with questions thru out the meeting and it  
was decided by majority vote, none not in favor, that Evelyn W. would  
serve as Secretary and Treasurer. She was reminded by the Utah delegate  
to be sure to have two signatures on Checking Account.

Chairman and Secretary live in towns close by.

Betty Ci [redacted] said she would send all remaining funds and all literature left over to the Secretary, Chairman and Delegate.

The meeting was taped and it will be kept for any group in Idaho to hear.

Meeting was adjourned by Betty Ti [redacted] ---til we meet again or until the banquet at 6:00Pm
