4. Submit a travel expense report to the Area Treasurer


What is an RSS?

A regional service seminar takes the World Service Office (WSO) out of Virginia Beach and brings it to the regions in the United States and Canada. Most members do not get the opportunity to visit the WSO, meet the staff, and hear about the work being done. Even if you do visit, the picture of the WSO is incomplete without meeting the volunteer Board of Trustees members. An RSS is the perfect place to: find enthusiasm for service; give each member of Al-Anon an opportunity to meet WSO staff and trustees. An RSS only happens once every 3 years in each region...so be part of the fun. Get your name in this May!



Exciting News...ECAL

- We are at the beginning of a new era in our efforts to share personal recovery throughout the worldwide fellowship of Al-Anon Family Groups. Now is the time to Al-Anon and Alateen members to submit messages of experience, strength and hope in a variety of creative formats for use as electronic Conference Approved Literature (e-CAL). The 2006 World Service Conference approved a three-year trial period to explore how members might produce and share e-CAL. The Conference motion created an opportunity to increase the relevance of the Al-Anon program for a worldwide audience that is immersed in various electronic communication media. Because this is a test, we do not know the final form e-CAL will take. Your creative presentation and suggestions can help make e-CAL into the communication vehicle that it is meant to be. Do you have a personal story, insight, feeling or hope that you would like to share? Are you moved to create music, poetry, or graphics to express what is in your heart? If you are looking for permission to share the spirit of your recovery with Al-Anon members who can relate to the way you experience life, e-CAL would like to offer you that permission. Members will review your submissions according to the criteria established for Conference Approved Literature. They will be looking for presentations that especially lend themselves to electronic delivery. If your submission lends itself to better use as printed literature, we reserve the right to forward that material to the Forum Editorial Advisory Committee or the Literature Committee.

- The CAL criteria is;

Identifiably Al-Anon in content and feeling

Responsive to identified needs

Factually accurate

Timely

Understandable by a broad-based audience

- We invite you to make e-Cal an enjoyable and rewarding recovery environment for a wide range of Al-Anon members. Please include personal contact information with your

submission so we can call or email you to overcome and technical difficulties. See you on the World Wide Web at www.al-anon.alateen.org/members To access the Members' website, remember to use the name of your home group and the letters AFG as your password. Here's how far we've come to date:

- The WSO Executive Committee has approved a process to ensure that e-CAL will be as reliable a resource for Al-Anon recovery as already published Conference Approved Literature.
- The two literature committees have been consolidated into a single Literature Committee, and an e-CAL Committee has been created.
- After a call for resumes, seven At-Large members and 11 Delegates have been selected as members of the e-CAL Committee.
- The staff has developed a technology strategy to implement e-CAL. We've acquired a new server. As a security precaution, we installed a key piece of communications hardware that will keep e-CAL activities entirely separate from the WSO's current wired and wireless network. This approach will ensure that any computer virus embedded in any e-CAL submission will not contaminate Al-Anon's other computer operations. We have tested our new network configuration and written software for additional security protection from computer viruses.
- The staff has designed a home page for e-CAL where it will reside on the Members' website at www.al-anon.alateen.org/members The e-CAL home page will be the place where members can submit their e-CAL proposals in a variety of standard formats.

LIT COORD REPORT



FORUM COORD REPORT

My sponsors have always said that when Al-Anon asks something of you, say yes as a matter of course. So when I was asked to be a part of the Area Committee I accepted with at least a little fear in my heart. My new position was to be Area Forum Coordinator. I really have no idea what I'm doing but the interaction and association with the winners of this program is worth any anxiety I might have.

Looking through the pages of my beloved Forum I now look with a new eye. Where is Idaho? I see Oregon, Minnesota, Puerto Rico, Guam, but where is Idaho? So my first two Assemblies in my new position I had a poster about the Forum. I had handouts about writing to the Forum and every chance I had I spread the word. Write to the Forum, it's a therapeutic part of recovery, both the reading of the Forum and sharing in the Forum.

In December, 2005, I was asked to speak in Boise, another of those things that when Al-Anon asks you say yes. The event had a wonderful Potluck meal, an AA speaker and me. My story of recovery includes the Forum, both for the help I have received reading its pages and for the benefit of having written an article and seeing it published. When I finished and as we were packing up a woman passing by me said, "I'm November, 2005!" I'm not alone!!

Never satisfied, I wonder why there isn't more; and then I had a quick flash back to the years that didn't work as well as those now and I remembered. My husband, son and I were caught in a dismal cycle of negativity. The atmosphere in the house was toxic. None of us were happy and **all** said "Well, if you'd just quit doing, or saying, or thinking that we all could be happy" Of course when you're all focused on what someone else could do, say or think you're **not** focused on what you need/must do to be healthy and serene and no one gets better. How did I get better all those years ago? I worked this marvelous program to get rid of my own negativity, refusing to buy into the games the family was playing. Using the pages of the Courage to Change, One Day at a Time and the Forum I bit my tongue, took unexpected walks and changed my thinking. The miracle is almost anticlimactic; as I changed so did my husband and son. Looking back I'm not really sure they were even part of the problem, they could have been innocent victims of my own negativity. My view of the world was so sour and dismal at the time.

Ah, but how does that tie into the present and my job as Area Forum Coordinator? I decided that as I encouraged I needed to do. No more pointing at THEM without including my own recovery in the process. So here's my Forum article!

THE NEED FOR AL-ANON IN INSTITUTIONS

I challenge all the districts to go into your community and start a new institution meeting. This would include any treatment centers, hospital alcoholism unit, correctional facilities, juvenile detention centers, group homes, halfway houses, shelters-homeless/battered women's shelters.

The purpose of this outreach is to bring the Al-Anon/Alateen program to the families and friends of alcoholics in treatment centers, correctional, or other residential facilities.

Acquaint the staff with the video (AV-31), provide Al-Anon/Alateen posters and literature to the facilities.

Provide programs for "family night" at treatment centers. Help clients and their families find Al-Anon after they leave the facility by providing meeting lists and/or copies of *Getting in Touch with Al-Anon/Alateen* (S-23)

A good tool to have is *The Best of Public Outreach* (P-90). This has a lot of great ideas and activities. I encourage all districts to order one.

ARCHIVE COORD REPORT

The last few weeks, I've been going through 25 years of Assembly Folders in two big boxes, a chore I have put off for a long time (as you can tell).

Flyers and the programs go into 3-ring binders by year. Area minutes are in other binders.

During the years, someone would hand me something for archives and I'd stick it in that particular Assembly Folder for that year. So I've come up with some interesting items about which I'd forgotten.

One in particular: 1979 list of Al-Anon and Alateen Information Services, Intergroups and Service Centers for United States and Canada lists Idaho Falls All-Anon Information Service with Linda and Beth as the contact persons. This was before Boise was listed and I don't have that year at hand. It is in another binder or folder.

The 1973 new Al-Anon group starter packet was sent to Linda H. in California before she moved to Idaho Falls. The cost to mail it was 28 cents. Most information to get started was in letter-size paper, not the nice easy-to-read pamphlets that are sent out currently.

Bob B., former delegate 1996-1998, died on January 31, 2007. The obituary was provided to the archives for a member that retrieved it from the internet. It's interesting what we don't know about our friends in Al-Anon. We try to keep our jobs, our religion, and our personal interests out of the meetings. Then read about the person "outside Al-Anon" in an obituary.

For the 1972 November Fall Assembly in Twin Falls, we have a transcript of speakers at the Al-Anon Conference (AA Assembly with Al-Anon participation). Speakers were our area mentors, Lou, a delegate from Utah, and Anna Marie, Public Relations Chairman from Salt Lake City, Utah, and Darlene P. of Idaho Falls.

In 1972, the Idaho Statesman printed an article by Betty T., our first delegate, telling of All-Anon, what it is, when it meets in Boise, and her own personal story. This was the first public information that gave the local Al-Anon groups new members or at least new inquiries. The article states that "further information can be obtained by calling the Grapevine Club" and then gave a telephone number.

Al-Anon had no office or hotline as we know it today. We still had to rely on the good partnership of AA to help us get started.

Step 1 Study Guide (in part)

Editor's Note: We're either on Step 1 or going back to Step 1. This is a good refresher.

1. Start journaling daily. Write down 5 emotions you felt that day and why (example: Frustrated/angry, I didn't get the raise I expected). The idea is to start being aware of your feelings & where they come from.


Next, look at what you're powerless over and how has it made your life unmanageable? Set up two columns: "Tried to have power over" & "Ways it's made my life unmanageable" (example: Tried to have power over my boss/my review & how much of a raise I'd get. Made my life unmanageable by causing me to resent my boss, he doesn't appreciate me, and I obsessed & was angry for 3 months about why I didn't get a better raise). Start doing this at the end of each day.

2. Follow the Step Study Guide for Step One. When you read from the literature, keep a notebook handy and jot down key thoughts that are important to you. We'll discuss these as part of your First Step, along with the questions at the end of the Study Guide.

3. Read all the pages on the Slogan "Live and Let Live" from the ODAT and Courage to Change. Jot down key thoughts.
