## Reports

#### Secretary's Report

Minutes for Spring 2015 Area Assembly were looked over by attendees. No changes were made. Cass – Approved, Linda Motioned. All were in Favor.

#### **Treasurer's Report**

#### Al-Anon Area 13 Proposed Budget for 2016

Kathy Ba. presented the proposed 2016 Budget. This report shows the proposed budget amount along with the budget/actual history for 2013 - 2015 YTD. The committee reviewed each expense category and found most proposed amounts appropriate. Those listed below were discussed at length until confidence was expressed that the amounts were appropriate.

Proposed Budget Item Changes for 2016							
Literature Center Liaison (Renamed <u>AAISC Liaison</u> )	= Because the AAISC funds the Liaison's meeting expenses similar to how a DR's expenses are funded by each District and because the position is not an Area Coordinator, discussion centered on whether to retain the \$20 budget item or delete it. It was agreed to move the line item from the Coordinator category to Budget because it is neither a Coordinator position nor an Operating Expense and change the title to AAISC Liaison. A motion was made and seconded to retain the item to fund Area-specific reporting expenses. Motion passed with 2 opposed.						
Assembly Literature (Deleted item)	<b>O</b> Discussion centered around deleting this item or moving it to Forum/Literature or Assemblies. A motion was made, seconded and passed unanimously to delete this \$20 line item because it funded CAL brochures and a display rack when Area Assemblies were combined with AA.						
Background Checks	↑Increased from \$200 to \$400. The number of Alateen sponsors has increased as have the costs for background check and fingerprinting.						
Equalizer expense	=Maintained at \$2,500 (which increased last year to this amount) to cover anticipated expenses for our Delegate to attend the WSC. The equalizer expense is the amount billed by WSO and paid by Area by January 1.						
Financial Review	↑Increased from O to \$600 to cover the required review of our books every 3 years. The last review was last completed in 2013.						
NWR Delegate meeting	=Maintained at \$1,800. Area pays for the delegate to attend every year and for the Alternate and Past Delegate to attend once/term.						
TEAM Event	This event is a partnership between Area and a WSO Task Force working together to plan an agenda of workshops and

Ladora – Service manual states to pass the basket according to 7<sup>th</sup> Tradition. To contribute in gratitude. Newcomer packets cost \$1.25 each, \$1 donations is not enough to cover this cost.
