Texas Attorney General Ken Paxton to Keynote Childproof America Luncheon





Ken Paxton is the 51st attorney general of Texas. He was elected on November 4, 2014, and sworn into office on January 5, 2015.

His first major initiative as attorney general was the formation of a special unit dedicated to combating human trafficking in Texas. During its first year of existence, the Human Trafficking and Transnational Organized Crime (HTTOC) section helped arrest the chief executive officer of Backpage.com, the largest online sex-trafficking marketplace in the United States.

Special Presentation by Kimberly Grabert

Director, Human Trafficking and Child Exploitation for Texas Department of Family and Protective Services

State officials launched a long overdue new initiative to help victims of sex trafficking. Kim Grabert has been named the state's first ever Director of Human Trafficking Prevention. She is leading the charge for more funding and resources to address this issue that is a priority for Houston and other cities statewide. A recent University of Texas study estimated the state has more than 300,000 human trafficking victims. "The largest hurdle initially is to have everybody have an understanding of this issue of sex trafficking," Grabert said. "Texas is at a place where I think we've been building up to this conversation, and I think now is the right time to have staff in positions to address it."

> HOUSE PASSES MCCAUL'S BILL TO COMBAT HUMAN TRAFFICKING

WASHINGTON, D.C. – The House unanimously passed H.R. 4708, the DEPARTMENT OF HOMELAND SECURITY BLUE CAMPAIGN AUTHORIZATION ACT OF 2017_[12]. This bipartisan bill, introduced by House Homeland Security Chairman Michael McCaul (R-TX), helps protect victims of human trafficking by providing the right tools to federal, state, and local law enforcement, as well as private sector organizations to increase awareness and better defend against this heinous threat.

> KEY POINTS OF THIS LEGISLATION INCLUDE:

* H.R. 4708 authorizes the Department of Homeland Security's (DHS) efforts to deter, detect, and mitigate instances of human trafficking. * It provides resources that will allow DHS to continue partnering with state, local, tribal, and territorial entities to provide training on how to raise awareness of human trafficking and coordinate efforts to prevent it. * This bill also directs the Department to disseminate intelligence and best practices related to human trafficking trends and mitigation efforts. * Finally, the bill bolsters DHS efforts to coordinate among public and private stakeholders, including government agencies, private entities, law enforcement partners, and nongovernmental organizations efforts to raise public awareness on the threat human trafficking poses to our communities nationwide.
