Protecting Children's Coverage: An Advocacy Toolkit for AAP Members, Leaders and Chapters

The American Health Care Act (AHCA) recently passed through the House by a narrow margin in May. The bill has now gone to the Senate for their input and revision. The AAP has released statements opposing the bill in its current form. The CBO estimates 23 million people will lose health coverage by 2026. This will disproportionately affect children. The bill also eliminates required coverage of essential health benefits and allows insurers to discriminate against patients with preexisting conditions by charging them unaffordable premiums. This is a critical period for the Senate bill as it is being actively worked on by the senators and it is the perfect opportunity for pediatricians to voice their concerns.

The advocacy tool kit created by the AAP contains resources to help pediatricians engage with their members of Congress. It is vitally important that we speak up for our patients and protect their access to health care. You can access the tool kit at: federaladvocacy.aap.org.

Our chapter has launched an ongoing advocacy project to discourse with legislators in our state about this important topic. We have sent letters to Governor Sandoval, Senators Cortez Masto and

AAP Policy Corner

Fruit Juice in Infants, Children, and Adolescents: Current Recommendations

Abstract:

Historically, fruit juice was recommended by pediatricians as a source of vitamin C and as an extra source of water for healthy infants and young children as their diets expanded to include solid foods with higher renal solute load. It was also sometimes recommended for children with constipation. Fruit juice is marketed as a healthy, natural source of vitamins and, in some instances, calcium. Because juice tastes good, children readily accept it. Although juice consumption has some benefits, it also has potential detrimental effects. High sugar content in juice contributes to increased calorie consumption and the risk of dental caries. In addition, the lack of protein and fiber in juice can predispose to inappropriate weight gain (too much or too little). Pediatricians need to be knowledgeable about juice to inform parents and patients on its appropriate uses.
