Introduction to Ballet

Introduction to Ballet is a 16 week group class for girls ages 7-10 years old. This class will consist of weekly one hour classes designed to learn proper ballet technique and alignment. Classes will begin Friday, February 2nd at 4:30pm and will run through until the last class on Friday, May 18th.

The fee for each one hour session is \$25.00. Classes will be paid for by the month with check, cash or credit card. If you choose to pay for the 16 weeks up front there will be a 10% discount applied. All payments are final and there will not be any makeup classes offered for missed sessions.

Proper ballet attire is required. This includes a leotard, tights and ballet slippers. There is no preference on color as each student is an individual. Please have hair tied back and away from face. Our studio has a changing room and doors will open 15 minutes prior to class to accommodate the needs of our students.

Accident Waiver and Release of Liability Form

All participants and students must complete this form before participating in any classes at the Jennie Somogyi Ballet Academy. If participant is under age 18, a parent or guardian must also sign this form. Admission to class will not be granted if this form is not received prior to class and is not properly signed.

Waiver of Liability I recognize and understand the risks of physical injury inherent to dance and dance training and I fully assume those risks. I hereby release The Jennie Somogyi Ballet Academy, event sponsors, employees, volunteers and dance teachers from all liability for injuries sustained or illnesses contracted while attending or participating in any dance classes, rehearsals or workshops. Protection of Property I understand and agree that it is my sole responsibility to safeguard my personal property while attending or participating in any classes, rehearsals or workshops. I hereby release The Jennie Somogyi Ballet Academy, event sponsors, employees, volunteers and dance teachers from all liability for loss or damage to my personal property while attending or participating in classes, rehearsals, workshops, or performances. Medical Attention In case of physical injury or medical emergency, I hereby authorize The Jennie Somogyi Ballet Academy to make necessary arrangements to transport myself or my child to a medical treatment facility as necessary. All such transportation and medical treatment will be at my sole cost and expense. In extreme emergency, or if my child is under 18 years of age, I understand that The Jennie Somogyi Ballet Academy will attempt to notify the person(s) I have named below as my emergency contact(s) of my condition and how to reach me.
