On the defensive side of the ball, the Mustangs had a lot of good aspects. The defensive line formed

a strong wall against the opposing team's line and the safeties read the plays very well. Claude's defense showed vast improvement over last season and leaves hope that there are many positive changes still to be seen this season.

The Mustang's Special Teams had a 32.3 punting average and a 3 average for punt return. Despite the combined

efforts of all the players and coaches, Claude ultimately fell to Trinity Christian by a final score of 0-24.

The Mustangs ended the first game of the season with lots of room to grow and a lot of potential in their future games. Coach Vedran Krtalic commented, "The team definitely has room for improvement, but I see lots of good things in our

future. I look forward to this season and all the potential we have left to unlock from our players." Our mighty Mustangs play away next week in Sayre, Oklahoma, where they hope to gain the victory in their second game of the season.

The story of blind Bartimaeus in Mark's Gospel (Mark 10:40-52) is the story of a man desperate for God. As Jesus was passing through Jericho for the very last time a beggar cried out, "have mercy on me, son of David!" This one beggar in a sea of beggars got the attention of Christ. As Jesus stopped, having heard the cry of this blind man, He responded to the shout of desperation in a surprising way. Christ simply asked, "What do you want Me to do for you?"

This is a great question that each of us needs to answer. What do you want Jesus to do for you? Is he a bandage when what you really need is spiritual surgery? Is he nothing more than an ec-

clesiastical bishop that you expect to be available at your beck and call? Is he like Jolly old St. Nick searching for good boys and girls to give toys to?

Do you even have a specific answer to your question?

I've met believers who get desperate only when they get in a pinch. They make all kinds of promises to God, but when they get out of the bind, they go back to their old ways. There promises are fleeting. Their interest in the Lord was temporary. They want what God can do for them, but they don't really want Him. We live in a time when more and more believers are giving the wrong answer to the question Jesus is asking. If Jesus were to pass by and ask you, "What do you want Me to do for you?" Most of us would have self-centered answers. I would imagine the average believer say something like:

- I'd like to find the right spouse.
- I'd like to get out of debt.
- I'd like to have a new car.
- I'd like to win the

Powerball.

- I'd like to have a life free from pain and suffering.

Unfortunately most of our answers would have little or nothing to do with the glory of God in our lives. Only desperate people get to the point where it's not about them but about the Lord.

If you read the story, you will find Jesus told him to go on his way, but

he followed Jesus. Having been delivered, he chose to be a disciple. He walked out of Jericho with the Lord. Where was Jesus heading? To the cross. I'm convinced God will answer your prayers of desperation if in your answer Jesus is glorified and the cross is magnified. Anything less than God's Glory is selfish and self serving.

How to Optimize Your Home Office

(StatePoint) The old 9-to-5 isn't what it used to be. As more companies embrace telecommuting, a growing number of employees are finding that even in the professional realm, there's no place like home.

- Get comfortable. Don't

just grab an extra dining room chair. Chair designs have improved thanks to ergonomic research over the last half century. Choose one that will keep your posture vertical and your mind sharp.

- Get lit. Ideally, your home office will have at least one window, but also invest in a swing-arm desk lamp to provide ample illumination for concentrated tasks.
- Clear clutter. Avoid toppling stacks of documents and make the recycling bin your new best friend. A small filing cabinet should be able to hold all your records, and many home furnishings can be repurposed if a filing cabinet feels too corporate.
- Grow something. Not only are there health benefits associated with keeping plants indoors, they'll be there when you need to take a break. A little gentle pruning can prove meditative, and can be a good way to refocus.
- Keep a schedule. Online newsfeeds and day-to-day housework

can be distracting. Approach working at home with the same level of professionalism you'd bring to an office setting. Display a clock and wall calendar for visual reminders of deadlines.

- Communicate. Responding promptly to emails and calls lets co-workers know that you're reliable. Substitute face-to-face time with FaceTime (or another video-enabled communication service). Thanks to such technology, you can share space with co-workers a continent away.
- Take breaks. Anyone familiar with water cooler chatter knows that offices are highly social. That's an aspect of your day that can feel like it's missing. So step outside every few hours; wave to your neighbor or walk to a coffee shop.

PUBLIC NOTICE Brief Explanatory Statements of Proposed Constitutional Amendments Special Election, November 7, 2017

Proposition Number 1 (HJR 21)

HJR 21 proposes a constitutional amendment that would permit the Texas legislature to expand the circumstances under which a partially disabled veteran or their spouse may qualify for an exemption from ad valorem taxation of part of the market value of the veteran's residence homestead. Currently, the Texas legislature may provide that a partially disabled veteran or their spouse is entitled to an exemption from ad valorem taxation of a percentage of the market value of the disabled veteran's residence homestead only if the residence homestead was donated to the disabled veteran by a charitable organization at no cost to the veteran. The amendment would allow the Texas legislature to provide that the exemption also may be taken when the residence homestead was donated, sold, or transferred to the disabled veteran by a charitable organization for less than the market value of the residence homestead. The amendment also harmonizes certain related provisions of the Texas Constitution.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of part of the market value of the residence homestead of a partially disabled veteran or the surviving spouse of a partially disabled veteran if the residence homestead was donated to the disabled veteran by a charitable organization for less than the market value of the residence homestead and harmonizing certain related provisions of the Texas Constitution."

Proposition Number 2 (SJR 60)

SJR 60 proposes a constitutional amendment to require that certain conditions be met for the refinancing of a home equity loan to be secured by a voluntary lien on a homestead. The amendment also would: redefine what is excluded in the calculation of the cap on fees associated with a home equity

loan, lower the cap from 3% to 2% of the original principal amount of the extension of credit, and specify that such fees are in addition to any bona fide discount points used to buy down the interest rate. The amendment would further specify the list of authorized lenders to make home equity loans, change the threshold for an advance of a home equity line of credit, allow agricultural property owners to acquire home equity loans, and update technical terminology in the Texas Constitution. The amendment would be effective on January 1, 2018, and applicable only to a home equity loan made or refinanced on or after that date.

The proposed amendment would appear on the ballot as follows: "The constitutional amendment to establish a lower amount for expenses that can be charged to a borrower and removing certain financing expense limitations for a home equity loan, establishing certain authorized lenders to make a home equity loan, changing certain options for the refinancing of home equity loans, changing the threshold for an advance of a home equity line of credit, and allowing home equity loans on agricultural homesteads."

Proposition Number 3 (SJR 34)

SJR 34 proposes a constitutional amendment that would prevent certain office holders from serving indefinitely beyond the expiration of their term. Office holders who are appointed by the Governor and confirmed by the Senate and receive no salary would only be able to serve until the last day of the first regular session of the Texas legislature that begins after their term expires.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment limiting the service of certain officeholders appointed by the governor and confirmed by the senate after the expiration of the person's term of office."

Proposition Number 4 (SJR 6)

SJR 6 proposes a constitutional amendment that would allow the Texas legislature to require any court that is hearing a challenge to the constitutionality of a state

statute to notify the attorney general of that challenge, if the party raising the challenge notifies the court that the party is challenging the constitutionality of such statute. Additionally, the amendment would allow the Texas legislature to set a period of not more than 45 days following the notification to the attorney general that the court must wait before rendering a judgment that a state statute is unconstitutional.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to require a court to provide notice to the attorney general of a challenge to the constitutionality of a state statute and authorizing the legislature to prescribe a waiting period before the court may enter a judgment holding the statute unconstitutional."

Proposition Number 5 (HJR 100)

HJR 100 proposes a constitutional amendment to provide a more detailed definition of "professional sports team" for purposes of their charitable foundations, which the Texas legislature may permit to hold charitable raffles. The amendment also deletes a requirement that an eligible professional sports team charitable foundation permitted by the Texas legislature to hold charitable raffles had to be in existence on January 1, 2016.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment on professional sports team charitable foundations conducting charitable raffles."

Proposition Number 6 (SJR 1)

SJR 1 proposes a constitutional amendment that would allow the Texas legislature by general law to provide that a surviving spouse of a first responder who is killed or fatally injured in the line of duty is entitled to receive an exemption from ad valorem taxation from all or part of the market value on the surviving spouse's residence homestead, as long as the surviving spouse has not remarried since the death of the first responder. It would also allow the Texas legislature to provide that the surviving spouse, who qualifies and receives the exemption and then qualifies a

different property as the surviving spouse's residence homestead, receive an exemption from ad valorem taxation of the different homestead in an amount equal to the dollar amount of the exemption of the first homestead for which the exemption was received in the last year in which the surviving spouse received the exemption for that first homestead. Like the initial exemption, this benefit will only remain available if the surviving spouse has not remarried since the death of the first responder. The proposed amendment would apply only to ad valorem taxes imposed for a tax year beginning on or after January 1, 2018.

The proposed amendment would appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of all or part of the market value of the residence homestead of the surviving spouse of a first responder who is killed or fatally injured in the line of duty."

Proposition Number 7 (HJR 37)

HJR 37 proposes a constitutional amendment that would allow the Texas legislature to make an exception to the law regarding the award of certain prizes. Currently, the Texas Constitution requires the Texas legislature to pass laws prohibiting lotteries, raffles, and other programs where the award of gifts is based on luck or chance. The proposed amendment would make an exception to this general rule to allow the Texas legislature to authorize credit unions and other financial institutions to institute programs which, in order to encourage savings, would award prizes based on luck or chance to the credit union's or financial institution's customers.

The proposed amendment would appear on the ballot as follows: "The constitutional amendment relating to legislative authority to permit credit unions and other financial institutions to award prizes by lot to promote savings."

Time will Tell what Harvey did to Texas Coastal Landscapes

ANGLETON — Unlike people and animals, plants can't evacuate when threatening weather approaches, and long tenures in flood waters can take a toll.

But as water recedes and people recover their homes in the aftermath of Hurricane Harvey, landscapes also will need to be watched for signs of stress, said Stephen Brueggerhoff, Texas A&M AgriLife Extension Service horticulture agent in Brazoria County.

"A little bit of rain is not too bad, but too much rain can be detrimental to the health of any plant," Brueggerhoff said. "These were extraordinary circumstances, so at this point it is really just a matter of waiting to see what the impact is."

Brueggerhoff said soil saturation is key.

cerned with are saturated soils that create conditions for root rot," he said. "When the rain saturates the soils causing a collection of water, plants may be standing or submerged in water."

Once saturated, there are not many options to help perennial plants, he said, except to watch for signs of stress.

"The roots of all plants need oxygen through the soil," Brueggerhoff explained. "Once the soils get saturated, that creates an anaerobic environment where the roots are not getting proper oxygenation within the soils."

"Just wait a little bit for the plant to tell you if there are signs of decline. It is not necessary to move the plants immediately," he said. "But if stress does begin to show, the owner may decide to move those plants away from the saturation."

Stress reveals itself in plants through discoloration, often as yellowing or purplish leaves, he said.

Another situation that

might impede plant recovery is debris that remains from floods.

"When the water recedes, there may be other organic matter deposited on the plants," he said. "As soon as you can get to the plants, pull off that matter and let that area dry out a little bit."

When the soil is less saturated, Brueggerhoff said, residents can return to "regular maintenance mode."

"If we get into the rest of our summer without unusually heavy rains, soils appear not to be supersaturated, and the plants are absorbing moisture from the soil, remulch them," he said.

Woody species such as shrubs and trees take longer to show stress, he noted.

"They often don't tell us too quickly what is going on with them as far as decline. Sometimes we will not see a tree or shrub responding to those kinds of environmental conditions for six months to a year," Brueggerhoff said.

He described an ash tree that stood in 4 feet of water near his home for two days.

"The water receded quickly, so two days of saturation probably is not going to hurt that tree," he said. "But if we have plants that are under saturation for up to a week, for some plants it can cause a decline in the long run. Sometimes those kinds of conditions can be an entry point for other pathogens to grow. And things of that nature can cause the plant to decline in the long run."

"At this point, it is just a matter of waiting to see how our plants respond."

This application was submitted to the TCEQ on August 14, 2017. The executive director has completed the administrative and technical reviews of the application and determined that the application meets all of the requirements of a standard permit authorized by 30 TAC § 116.611, which would establish the conditions under which the plant must operate. The executive director has made a preliminary decision to issue the registration because it meets all applicable rules. The application, executive director's preliminary decision, and standard permit will be available for viewing and copying at the TCEQ central office, the TCEQ Amarillo regional office, and the Armstrong County Courthouse, 100 Trice Street, Claude, Armstrong County, Texas, beginning the first day of publication of this notice. The facility's compliance file, if any exists, is available for public review at the TCEQ Amarillo Regional Office, 3918 Canyon Dr, Amarillo, Texas. Public Comment/Public Meeting. You may submit public comments or request a public meeting. See Contacts section. The TCEQ will consider all public comments in developing a final decision on the application. **The deadline to submit public comments or meeting requests is 30 days after newspaper notice is published.** Issues such as property values, noise, traffic safety, and zoning are outside of the TCEQ's jurisdiction to consider in the permit process.

The purpose of a public meeting is to provide the opportunity to submit comments or ask questions about the application. A public meeting about the application will be held if the executive director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing. If a public meeting is held, the deadline to submit public comments is extended to the end of the public meeting.

Contested Case Hearing. You may request a contested case hearing. The applicant or the executive director may request that the application be directly referred to a contested case hearing after technical review of the application. **The deadline to submit a request for a contested case hearing is 30 days after newspaper notice is published.** A contested case hearing is a legal proceeding similar to a civil trial in state district court. **If no hearing request is received within this 30-day period, no further opportunity for hearing will be provided, and the executive director may approve the application. A person who may be affected by emissions of air contaminants from the facility is entitled to request a hearing. To request a hearing, a person must actually reside in a permanent residence within 440 yards of the proposed plant. If requesting a contested case hearing, you must submit the following: (1) your name (or for a group or association, an official representative), mailing address, daytime phone number; (2) applicant's name and registration number; (3) the statement "[I/we] request a contested case hearing;" (4) a specific description of how you would be adversely affected by the application and air emissions from the facility in a way not common to the general public; (5) the location and distance of your property relative to the facility; (6) a description of how you use the property which may be impacted by the facility; and (7) a list of all disputed issues of fact that you submit during the comment period. If the request is made by a group or association, one or more members who have standing to request a hearing must be identified by name and physical address. The interests which the group or association seeks to protect must be identified. You may submit your proposed adjustments to the application which would satisfy your concerns. See Contacts section.

TCEQ Action. After the deadline for public comments, the executive director will consider the comments and prepare a response to all relevant and material, or significant public comments. The executive director's decision on the application, and any response to comments, will be mailed to all persons on the mailing list. Survivor Housing a Priority for the Federal and State Recovery Effort after Hurricane Harvey

WASHINGTON — The federal government continues to focus on the lives and safety of those affected by Hurricane Harvey. While the coordinated response continues, the U.S. Department of Housing and Urban Development (HUD), Federal Emergency Management Agency (FEMA), and other federal, state, local, and tribal partners, are beginning to direct efforts toward recovery, including housing survivors displaced by the disaster through the state-led disaster housing task force.

HUD is the lead federal coordinating agency for long-term disaster-related housing needs resulting from Hurricane Harvey. Federal partners are working closely with the Texas state-led housing task force, as well as other state, local, tribal and voluntary agencies, to meet the need for quality affordable rental homes. They're also focused on identifying strategies to strengthen the housing market, building inclusive and sustainable communities, and integrating disaster mitigation measures into community design and development, to reduce future damages.

HUD is primarily supported by the U.S. Department of Agriculture, U.S. Department of Justice, FEMA and other federal departments, agencies and national organizations. Below is a summary of the short-term, intermediate and long-term efforts already underway:

Short-term Housing Activities

- For those who are eligible for FEMA assistance, **FEMA transitional housing assistance** provides lodging to displaced survivors

who need a place immediately. FEMA pays the hotel/motel directly for this assistance.

- **Local communities, the American Red Cross, and other voluntary and faith-based agencies** are providing emergency shelter to those displaced by the storm and subsequent flooding.
- **AmeriCorps and other voluntary and faith-based organizations** are helping to clean out flood-damage to homes.
- **HUD** is immediately assisting those **displaced from public housing and multifamily subsidized rental units. Immediate foreclosure relief** may also be available for Texas residents. HUD is granting a 90-day moratorium on foreclosures and forbearance on foreclosures of Federal Housing Administration (FHA)-insured home mortgages.

Intermediate and Long-Term Housing Activities

HUD's giving communities in Presidentially-declared disaster areas, the flexibility to redirect millions of dollars in annual CDBG and HOME formula funding to address critical needs, including housing and services for disaster survivors. In addition, HUD is:

- **Making mortgage insurance available:** HUD provides FHA insurance to disaster victims who have lost their homes and are facing the daunting task of rebuilding or buying another home. Borrowers from participating FHA-approved lenders may be eligible for 100 percent financing;

- **Making insurance available for both mortgages and home rehabilitation:** HUD's Section 203(k) loan program enables those who have lost their homes to finance the purchase or refinance of a house along with its repair through a single mortgage. It also allows homeowners who have damaged houses to finance the rehabilitation of their existing single-family home; and

- **Offering Section 108 loan guarantee assistance:** HUD will offer state and local governments federally guaranteed loans for housing rehabilitation, economic development and repair of public infrastructure.

- **FEMA's Individuals and Households Program** provides financial assistance in the form of grants to survivors with uninsured or underinsured flood related losses. To-date, more than 176,000 individuals and households have been approved for more than \$141 million in assistance. Of that amount, \$50 million is approved for housing assistance, such as rental assistance. Survivors may use the rental assistance to obtain temporary housing such as a house, apartment, hotel, motel, or other readily-available dwelling for rent by the public.

- As part of FEMA's comprehensive approach to meet the post-disaster intermediate housing needs caused by Hurricane Harvey, FEMA is considering all available housing options for survivors. FEMA is working with federal, state and local partners to assess the temporary housing

needs and the best options to meet those needs.

- **The U.S. Small Business Administration (SBA)** provides low-interest loans to cover residential losses not fully compensated by insurance. Loans are available up to \$200,000 for primary residence; \$40,000 for personal property, including renter losses. As of September 1, 2017, the SBA has received 2,118 disaster loan applications, primarily for homes. The SBA has fielded 5,221 calls and completed 451 property damage inspections.

- **Insurance** proceeds help insured homeowners and renters to repair hurricane-damaged, or flood-damaged property more quickly. The National Flood Insurance Program is authorizing advance payments of certain NFIP claims to expedite recovery. Call your insurance agent to find out more or to file a flood insurance claim under the NFIP.

FAIR OR FOUL

While many conflicts start with bad feelings, they don't have to end that way. Sometimes people act in an unfair or "foul" way when they are in a conflict. Fouls make people feel more and more angry. People can also act in a fair way that settles a conflict and makes everyone involved feel good. This is called **resolution** to the conflict.

How to Deal with Bullies

- ▶ **Pretend not to hear.** Instead listen to your own **thoughts** and tell yourself, "That's their problem, not **mine**," and "I'm OK just the way I am."
- ▶ **Find a safe person** to talk to. Make a list of people you could talk to about being bullied or about **times** you have seen others being bullied.
- ▶ **Be a buddy.** Kids who are alone are more likely to be bullied. Make a plan to walk with a **friend** wherever you think you might meet a bully.
- ▶ **Don't bully back.** Getting angry and **fighting** back sometimes is just what the bully wants. It's dangerous too, because someone could get hurt.




