Pending Marina Rate Increase

Over the past several months, the Marina Advisory Committee and City Staff have been diligently reviewing the Marina's rate structure. The last Marina rate increase, was April 1, 2017.

Staff has conducted a survey of other marinas in the surrounding area and concluded that our rates are much lower than comparable market rates. Staff has determined that a 2% rate increase on moorage and various rate increases in other Marina services and offerings are now necessary to help offset increased operational costs and build reserves.

Some of the proposed new rates are:

- ~Storage Sheds \$134.80 monthly
- ~Guest Electricity \$5.00 nightly
- ~Environmental Compliance Fee \$7.29 monthly

A complete listing of all of the proposed new rates can be found in the office.

The City Council will be considering if these new rates are appropriate at their regular City Council Meeting on April 17, 2018 at 6:00 PM at City Hall. If approved by the City Council these new rates will go into effect on May 1, 2018.

While none of us likes to see rates increase, we hope you can understand the obligation we have to establish a Marina rate structure to ensure that we have a safe and well maintained facility.

As a City "Enterprise" fund we rely solely on the revenue generated from the Marina to maintain and operate our 43-year old facility.

Conditional Moorage Dates

Just a reminder that those of you on the main walkway, F and G docks (conditional moorage areas), are required to vacate your slips for large events in the summer. In 2018 there will be three times that we are requiring you to vacate your slip:

- WIRW: July 17th Vacate by noon July 23rd Return after noon
- Labor Day: August 31st Vacate by noon September 4th Return after noon
- Hydros: September 14th Vacate by noon
 September 17th Return after noon

Please vacate your slip by noon and return any time after noon. The marina will credit your moorage for these dates.

If you wish to stay for the hydros please let the office know. There will be an additional charge of \$1.00 per foot, per night added to your account.
