

Sugar Bars Legacy Sale Futurity

The SUGAR BARS LEGACY SALE is proud to present the **Sugar Bars Legacy Sale Futurity!** This program is designed to appeal to Sugar Bars Horse breeders, owners, trainers and exhibitors. The Sugar Bars Legacy Sale Futurity is held each year in conjunction with the Sugar Bars Legacy Sale.

GENERAL- RULES: All entries must be Sugar Bars bred according to the consignment rules established by the Sugar Bars Legacy Sale Association.

A horse can be shown in the yearling halter futurity, and then in the Ranch Horse Versatility Futurity as a 2 & 3 year old. If the horse wins as a 2 year old, then it becomes ineligible to compete in the Ranch Horse Versatility Futurity as a 3 year old. Please note that a horse can be shown in both the open and youth divisions.

This futurity is run under AQHA rules in regards to: animal welfare, conduct, drugs, equipment, procedures & etc., unless the Sugar Legacy Sale and Futurity rules read otherwise. Conduct on show grounds of members and non-members, exhibitors, trainers, owners, and their representatives, together with all other persons being present on show grounds such as spectators, shall be orderly, responsible, sportsmanlike and humane in the treatment of horses such as to promote the implementation of the show and promote fair, competition. Un-sportsmanship like or irresponsible conduct or any other form of misconduct, such as illegal, indecent, or profane, and the inhumane treatment of horses is prohibited. Show management may immediately expel offenders from show grounds and/or disqualify exhibitors and their horses in order to preserve the decorum of the show and shall file a written report with the SUGAR BARS LEGACY SALE ASSOCIATION.



SUGAR BARS LEGACY FUTURITY--CLASSES:

YEARLING HALTER-OPEN

HORSE ELIGIBILITY:

Yearling's- To be eligible to participate in the **Sugar Bars Legacy Sale Yearling Halter Futurity** the horse must have been SOLD as a weanling through the Sugar Bars Legacy Sale the year preceding the futurity and must have changed ownership. Change of ownership must be documented on official registration papers. Eligibility will follow the horse.

- Yearlings registered to immediate family members (children, siblings, parents, grandparents) or person-working for/representing the original owner/consigner will NOT be eligible.
- Sugar Bars Legacy Sale yearlings that were “no saled” or bought back by the original owner/consignor will NOT be eligible.

ENTRY FEES:

The **Yearling Halter-Open** classes have a \$150 per entry due by September 1st. **(For 2015 fee will be changed to \$75 per entry and entries will be accepted until one hour before classes begin on day of show.)** A late fee of \$50 can be paid and entries will be accepted up to the day of show.

Along with entry fee you must submit a completed entry form and copy of registration paper. Entry fees pay for show expenses: judge(s), arena rent, sound system, etc. Any money remaining will be applied to the purse.

RULES:

- Futurity will be held during the Sugar Bars Legacy Sale held each September beginning in 2012.
- Entry application, fees and copy of registration papers are due by September 1st, of current sale/show year.
- Prior to the start of the show you must present appropriate health (current health & coggins) and brand documents.
- Show expenses are the owner's responsibility (entry fees, stall fees, health inspection & coggins, brand inspection, etc)
- Each entry will be shown in a standard halter class.
- Presentation of awards/winnings will be presented during the annual Sugar Bars Legacy Sale.

Halter Open Class Payback \$2000.00 purse is to be divided equally among stallions/geldings class and the fillies class therefore \$1000.00 per class:

- The following is the payback explanation.

1st - 40% 2nd - 30% 3rd - 20% 4th- 10%

1-4 entries in the class pay- 1 & 2

5-8 entries in the class pay- 1, 2 & 3

9 or more entries in the class pay- 1, 2, 3 & 4

If there are not enough eligible entries competing in each class to use all the placing's as outlined in the purse breakdown & entry numbers; the money not used will revert back to the Sugar Bars Legacy Sale Futurity.

YEARLING HALTER-YOUTH

RULES:

- All open class rules apply except the following:
 - Entry must be owned by the youth, his or her parent, brother, sister or grandparent (or be pre-approved by the Sugar Bars Legacy Sale Association board prior to entry).
 - Stallions **can't** be shown by youth!
 - Entry fees: none

Sponsored awards will be presented during the annual Sugar Bars Legacy Sale. Awards presentation will be based on number of entries per class:

- 1-6 in class: all entries receive an award 7- or more in class: 1-6 will receive awards

YEARLING HALTER IN-HAND TRAIL- YOUTH

RULES:

- Youth Only Class
 - Any yearling horse is eligible to be shown.
 - Stallions **can't** be shown by youth!
 - Entry fees: none

Sponsored awards will be presented during the annual Sugar Bars Legacy Sale. Awards presentation will be based on number of entries per class:

1. Contestants enter the arena walking to judge, stop, set up horse and present to judge. Judging will be on how well the horse responds to the handler, not on conformation of the horse.
2. Contestant will proceed to put the horse through the prescribed obstacles. There will be four or more obstacles which might include: a bridge, poles to step through, markers to weave through, a barrier to jump, a box to complete a 360 spin or others, depending on the director. The horse will be judged on its athleticism and how well it responds to the handler.
3. Common faults will include refusal to participate, stumbling on obstacles, not responding to handler, general lack of control.
4. Upon completion of the course, the horse will be asked to trot in a complete circle and line up.

2 & 3 YEAR OLD RANCH HORSE- OPEN VERSATILTY

HORSE ELIGIBILITY:

2 & 3 Year Old's- To be eligible to participate in the **Sugar Bars Legacy Sale 2 & 3 Year Old Ranch Horse Versatility Futurity** the horse must have been SOLD as a weanling or a yearling through the Sugar Bars Legacy Sale the year or 2 years preceding the futurity and must have changed ownership. Change of ownership must be documented on official registration papers. Eligibility will follow the horse.

- Horses registered to immediate family members (children, siblings, parents, grandparents) or person-working for/representing the original owner/consigner will NOT be eligible.
- Sugar Bars Legacy Sale Sugar Bars Legacy Sale horses that were “no saled” or bought back by the original owner/consignor will NOT be eligible.

ENTRY FEES:

The **2/3-year-old Ranch Horse Futurity- Open** has \$150 per entry due by September 1st. **(For 2015 fee will be changed to \$75 per entry and entries will be accepted until one hour before classes begin on day of show.)** A late fee of \$50 can be paid and entries will be accepted up to the day of show. Along with entry fee you must submit a completed entry form and copy of registration paper. Entry fees pay for show expenses: judge(s), arena rent, sound system, etc. Any money remaining will be applied to the purse.

RULES:

- Futurity will be held during the Sugar Bars Legacy Sale held each September beginning in 2013.
- Entry application, fees and copy of registration papers are due by September 1st, of current sale/show year.
- Prior to the start of the show you must present appropriate health (current health & coggins) and brand documents.
- The Sugar Bars Legacy Sale promotes the Sugar Bars as a versatile bloodline. To demonstrate this versatility each entry will be shown in: Halter, Reining and Western Pleasure. Each class will be worth equal points. (Example: total points worth 90, each class is worth 30 points.) The show will begin with all entries competing in halter and then moving onto the Reining and Western Pleasure classes. We will draw for class position prior to the start of the show.
- Show expenses are the owner's responsibility (entry fees, stall fees, health inspection & coggins, brand inspection, etc)

Open Class Payback: \$1000.00 purse.

- Presentation of awards/winnings will be presented during the annual Sugar Bars Legacy Sale. The following is the payback explanation.

1st-40%	2nd-30%	3rd-20%	4th- 10%
1-4 entries in the class pay- 1 & 2		5-8 entries in the class pay- 1, 2 & 3
