- Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion The Inspection Committee has the authority to disallow a dog's entry into a test for lack of condition, and in such instances, applicable entry fees will be refunded.
- All AKC Rules regarding sportsmanship and conduct apply.
- This is a rain-or-shine outdoor event. Please plan accordingly.
- Please bring your own shade/rain cover, and chairs. City water is available on site.
- Electronic timers will be used. An electric, continuous loop will be used.
- Porta-potties are on site.
- Dogs must be under control on lead or crated unless running.
- A \$5 fine/per dog per occurrence will be assessed for any loose dog on the field not competing or for not picking up after yourself and your dog.
- YOU are responsible for controlling your dog(s) and children.
- Each dog requires an individual entry form indicating tests in which it is entered. Entries will not be accepted without fees (checks made to DAD), signatures, or the "Agreement" found on the Official AKC Entry Form. One form may be used per dog to enter all tests.
- Bitches in season and lame dogs will be excused. Entry fees will be refunded.
- The Starter is responsible for field safety and therefore he/she is in complete charge of all dogs and handlers on the field. In service to this responsibility, he/she has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve a testing dog.
- Dogs should be warmed up before and cooled down after running.

No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or its members and representatives.

FAST CAT Tests are open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications are eligible to enter. Females in season may not enter. A dog may enter only once per event (an event is defined by an event number).

ABOUT FAST CAT

Fast CAT is a timed straight 100-yard dash for dogs.

Dogs are held at the start line and the coursing lure is activated prompting the dog to follow chasing it to the finish line and into a catch pen. The course is completely fenced and dogs are run individually.

EARNING POINTS

- A. The dog's time to complete the 100 yard dash is converted into MPH. MPH = (204.545)/dog's time.
- B. A handicap system is applied to a dog's MPH to determine the number of points earned. The handicap system is based on the height of the dog at its withers:
 - 18" or greater = handicap is 1.0
 - 12" up to less than 18" = handicap is 1.5
 - Below 12" = handicap is 2.0
- C. Points = MPH multiplied by the dog's handicap

SUFFIX TITLES are earned by accumulating points. The following suffix titles will be awarded:

BCAT = 150 Points:

DCAT = 500 points;

FCAT = 1,000 points; and

FCAT followed by a number (e.g. FCAT 2) for every additional 500 points. These suffix titles will appear on the dog's pedigree, with a higher level title superseding a lower level title.

Ribbons will be awarded for qualifying runs.

A penalty of \$5 will be assessed for each loose dog not competing in the course in progress, and/or for 5+ minute delay of event.


