

Librarians Note: Read before uploading

If uploading on behalf of faculty please note some best practices:

- 1) Create an generic account for uploading papers
 - a. You can sign up for an generic account to upload as if you were any other user with this link: <https://osf.io/register/>
 - b. Use a generic name and email with inbox that is shared by multiple users for back-up and support.
 - c. This generic account is different from setting up an OSF institutional account which can be used to setup an institutions' branded landing page. This will provide single sign-on for authorized users to allow to affiliate projects with your institutions. - 2) If moving or copying papers from Digital Commons or SSRN – be sure to remove the cover page created by Digital Commons or an SSRN journal before uploading to LawArXiv.
- 3) If adding papers on behalf of faculty or scholars who are unregistered on LawArXiv, be sure to get their permission. While you can add unregistered author via email, the system will automatically send a message to the unregistered author using the email you have provided. Be sure also to check to see if an author is registered before adding as an unregistered author. The emails will be sent from Open Science Framework – the platform that houses LawArXiv.
- 4) Author permission tip: If attempting to gain permission from many authors at once – send an opt-out message. This will allow authors to take action to opt-out of LawArXiv, with permission granted as the default.
- 5) Licensing: 'No License' is clicked as a default. Before checking a more permissive license, be sure to check with your author.
- 6) Removing yourself as a contributor: Please note you will not be able to remove yourself as a contributor until at least one author has registered.
