Notice to Exhibitors

- The <u>safety of the dogs</u> is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.
- <u>Entry fees will not be refunded</u> in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee or the judge.
- Capitol Canine Training Club may cancel this event in extreme weather conditions.
- <u>Entry fees will not be refunded</u> if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, an Act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the Event Committee.
- Since <u>bitches in season</u> are not allowed to compete in this trial the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for this reason. The Trial Secretary must receive <u>written notification</u> of such a claim for refund by letter hand-delivered, emailed, or postmarked <u>before the trial commences</u>.
- The club will refund all but \$10.00 of the entry fee per day for injured or ill dogs. Written request for a refund must be made to the Trial Secretary prior to the start of the first trial day and a veterinarian's letter must be provided within one week of the trial.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case no refund of any fees paid will be made.
- <u>All dogs must be on leash or crated</u> at all times except when in the ring or when in the designated agility warm-up area.
- <u>Exhibitors are responsible for being at the ring gate when it is their turn to run.</u> The judge need not wait for any dog holding up a class. Capitol Canine Training Club has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required. Failure to be at ring gate could result in the exhibitor being marked absent.
- Entries must be made on Official AKC Entry Forms or copies <u>and must include the signed Agreement and Rules</u>. <u>Junior Handlers</u> must enter their JH# and complete back of form.

No un-entered dogs are permitted within 30' of the ring barriers.

Dogs Eligible to Enter

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or are approved Foundation Stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind or deaf, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the AKC Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

Height Divisions

AKC Jump Height Cards

All dogs competing in agility must **possess** an official AKC Jump Height Card. An official AKC Jump Height Card is defined as either a permanent jump height card, a valid temporary jump height form, copies of two different measuring forms (placing the dog in the same height class) dated on or after the dog's second birthday, or copies of three different measuring forms (two of which place the dog in the same height class) on or after the dog's second birthday. All dogs except those jumping 24" or 26" without jump height cards/forms must be measured/wicketed by the Judge of Record PRIOR to running in their class; this measurement will be valid for the weekend of trials only. If a Volunteer Measuring Official or an Agility Field Rep is present, all dogs without a valid jump height card/form must be measured at some time during the trial. If the dog cannot be measured by the VMO prior to running, it must be measured by the judge before its first run. You are not required to show your height card or send a copy with your entry. Limit of 10 dogs per envelope

All entries must be submitted on official AKC Agility entry forms, one dog per entry form. Photocopies of entry forms without the AKC Agreement are not acceptable. Unsigned, incomplete, or illegible entries are not acceptable.

If you would like confirmation that your entry was received before the trial has closed, please include your email address or enclose a self-addressed stamped postcard.

Entries cannot be changed once the trial has closed. Please check your entries.

Move-Ups

For the Saturday trial: MOVE-UPS close at 6:00 pm CST, Monday, April 16. Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

For the Sunday trial: MOVE-UPS close 30 minutes after the end of the trial on Saturday and must be submitted at the trial.

Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification had been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial.

Class Description

Please see the AKC Regulations for Agility Trials for current class descriptions. **Dogs must be entered only** in Regular Classes or Preferred Classes with no crossover between them allowed at the same set of trials.

Obstacles

Obstacles will conform to the requirements in the current edition of the AKC Regulations for Agility Trials. All contacts are rubberized.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
