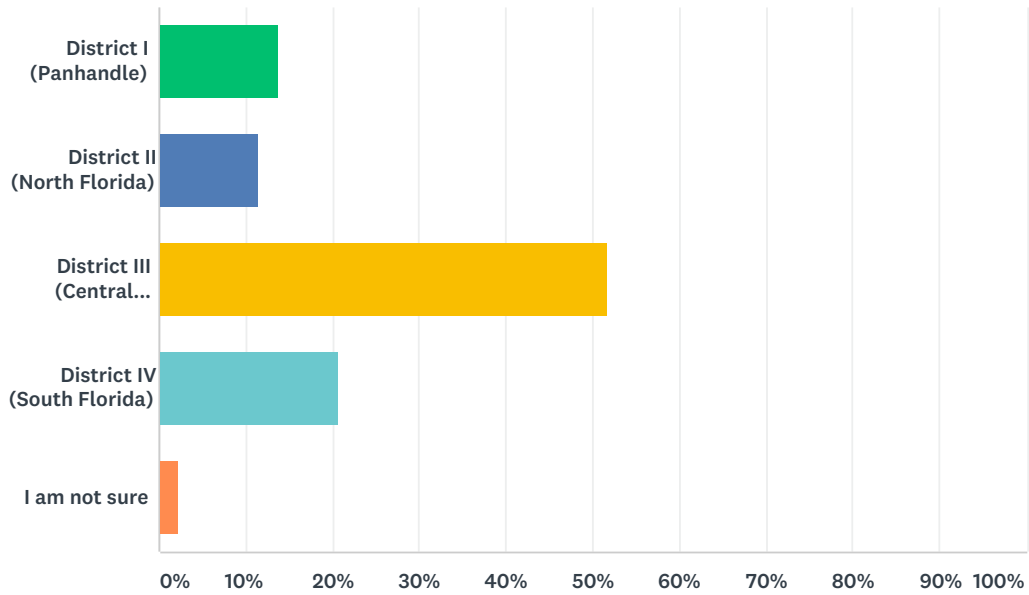


Q1 What District are you a member of?

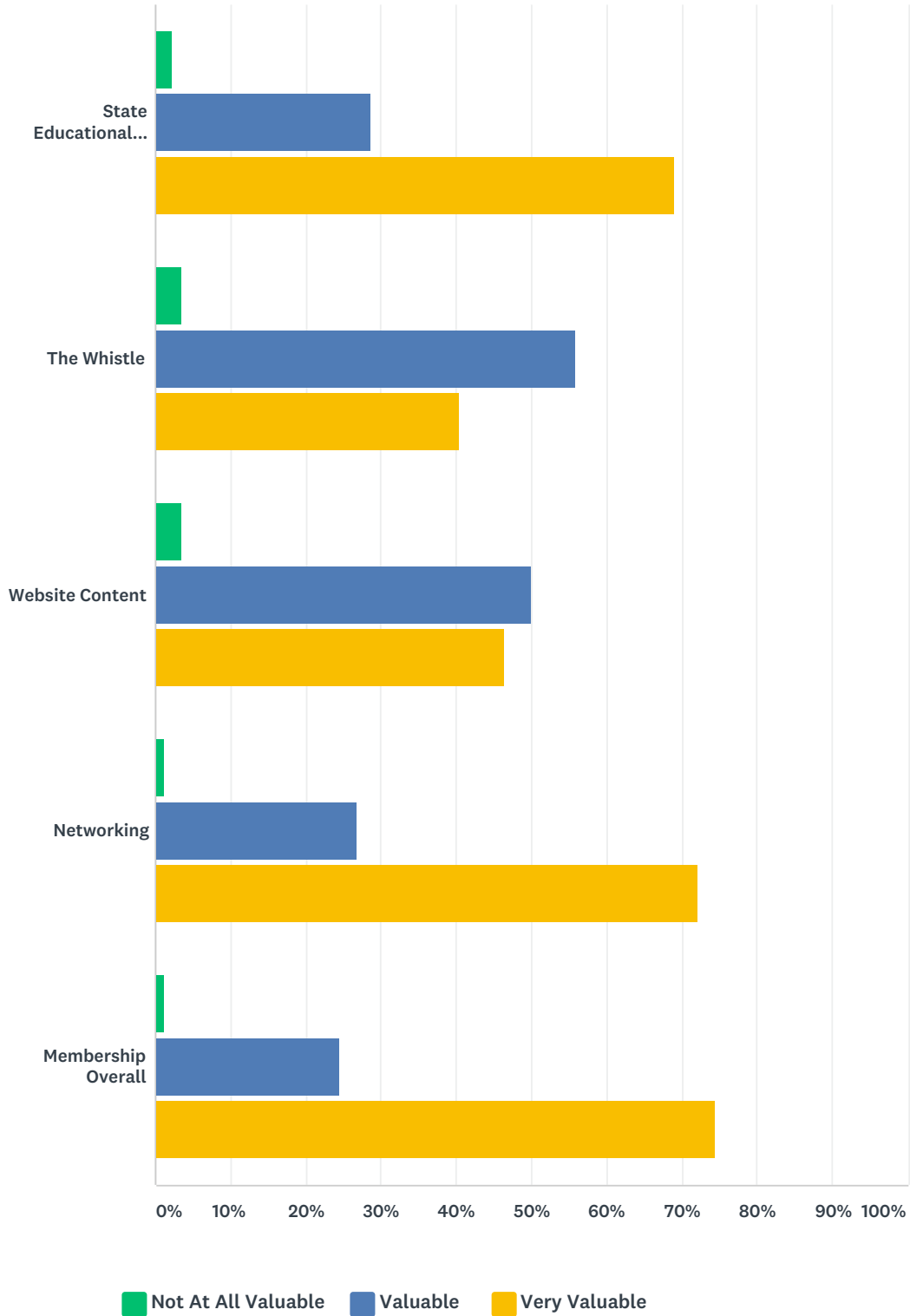

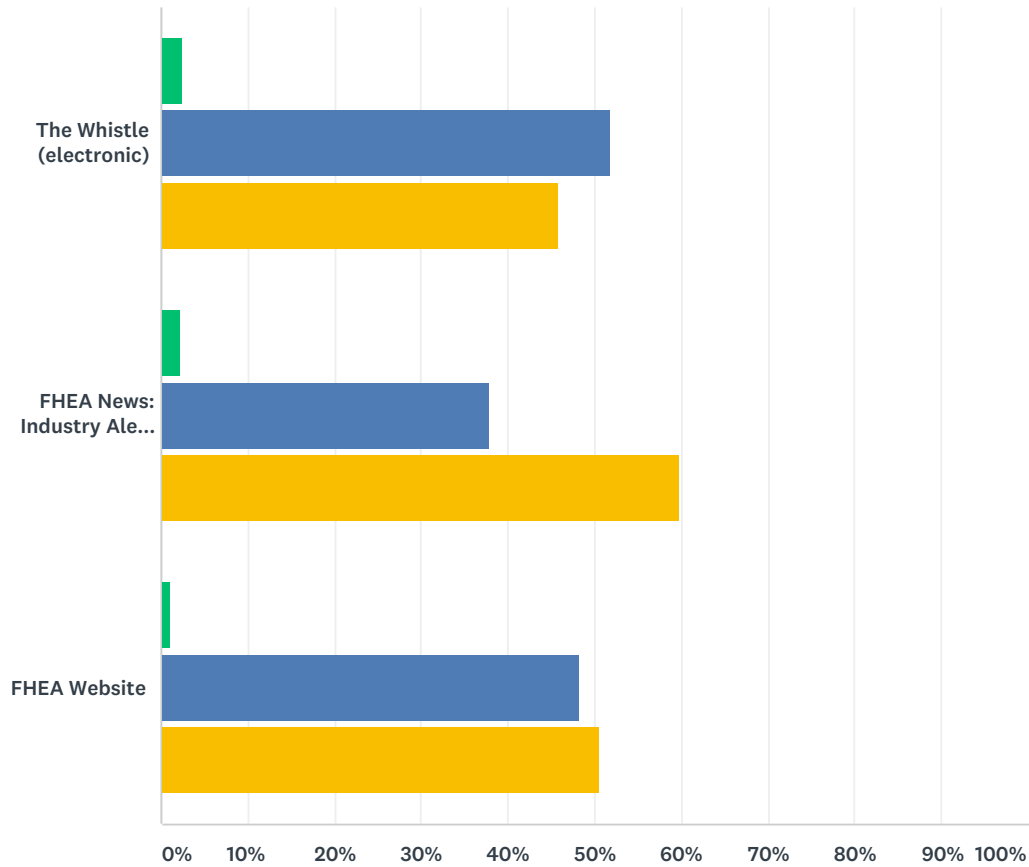
