## Asbestos Awareness in the Hospital Environment

#### Overview:

A discussion about asbestos in the work place; what does it mean if you have asbestos containing building materials present in your facility? Here are some questions and topics for discussion:

- Is your building construction 1980 or older?
- Per OSHA, EPA and ASHARA; what are building Owners and Operators required to do prior to demolition and renovation work in buildings that are 1980 construction or older?
- Have you conducted a comprehensive building wide asbestos survey?
- Do you conduct project specific asbestos surveys prior to any/all demolition / renovation projects?
- How do handle the demolition and removal of building substrates during an emergency response?
- Do you have an employee / vendor notification process in place per OSHA Hazard Communication Standard 1910.1200
- Asbestos Exposure Limits (PEL 0.1 f/cc) what does 1/10th of a fiber per cubic centimeter of air over an 8 hour period really mean?
