ATHLETE OBLIGATIONS

ATHLETE REQUIREMENTS:

- All athletes are required to wear athletic apparel (athletic shorts, t-shirts/tanks, sports bras, active leggings, and CHEER SHOES) with their hair up in a ponytail for all tumbling classes. NO STREET SHOES OR CLOTHES WILL BE ALLOWED DURING CLASS.
- Please bring a bottle of water to class.

ATTENDANCE POLICY:

Make up classes will only be permitted if the gym is closed and will need to take place in the same month that the class was cancelled. Make up classes will not be rolled over to the following month. They must be signed up for through Coach Keely or Coach Kitty, and may not just be attended without permission due to staffing concerns.

BULLYING POLICY:

Bullying will ABSOLUTELY not be tolerated!

- First offense- meeting with child, parent, and coach
- Second offense- suspension from class
- Third offense- suspension from gym until otherwise noted

FINANCIAL OBLIGATIONS

REGISTRATION FEE: All tumbling class registrants will be required to pay a one-time only \$10.00 registration fee due at the time that the registration form is returned to East Coast Cheer & Tumble, LLC staff. Registration form and fee required before participation in first free trial class or first class.

TUMBLING TUITION PRICING:

-First class is a free trial class, but may only be applied once per participant. Required for participation in first free class is completed registration form and \$10.00 non-refundable registration fee.

-Tumbling class tuition is only applicable to regularly scheduled classes and will not include open gyms, camps, etc.

- One class per week- \$55.00/month
- Two classes per week- \$80.00/month
- Private lessons are one hour in length and will need to be set up with instructor and paid for prior to start of lesson. Tumbling privates are \$20.00/hour and are to be paid directly to instructor and stunting privates (all-girl or co-ed) are \$35.00/hour and are to be paid to ECCT. **ATHLETE MUST BE A TUMBLE CLASS PARTICIPANT IN ORDER TO SCHEDULE PRIVATE LESSONS.**

***Tuition paid for a specific month will not roll over to the following month, regardless of if there have been unused classes.**

TUITION AGREEMENT:

I understand I will be responsible for payment of monthly tuition while my child/ward is enrolled at EAST COAST CHEER & TUMBLE, LLC. **I understand tuition is due and payable on the first of each month.** I understand and agree that if I have not paid for my child’s tuition by the 7th of each month to EAST COAST CHEER & TUMBLE, LLC this will result in **NO PARTICIPATION IN CLASS UNTIL ACCOUNT IS UP TO DATE WITH LATE FEE. IF PAYMENT IS MADE AFTER THE 7TH, IT WILL INCUR A LATE FEE OF \$10.00.**

TYPES OF PAYMENT ACCEPTED: CASH, CREDIT/DEBIT CARD, OR CHECK PAYABLE ONLY TO EAST COAST CHEER & TUMBLE, LLC. ANY RETURNED CHECK WILL INCUR A \$25.00 RETURNED CHECK FEE, AS WELL AS A LATE PAYMENT FEE OF \$10.00.
