

Blessings and Greetings,

All vendor and reader spaces are designated to 6' spaces. Vendors are usually around the perimeter of the rooms and the readers are either there or in the center of the room.

We're located at 445 S Alvernon Way – the Doubletree Hotel at Reid Park. You can find a map on Google or at our web site www.mysticmessengers.biz

All spaces are indicated on the Floor Plan for the next Fair. This is a private floor plan and not posted on the web. Once you have been given clearance to have a space, a floor plan map will be provided within a week of the next event.

Rules are very short and easy to follow:

- 1) **All spaces** are \$80 per Fair due 5 business days after the previous Fair. This rate is subject to change, but we anticipate no changes before Dec 10, 2018. You may pay after a due date, but your exact space is no longer guaranteed. There are never any refunds under any circumstance and you may not transfer funds to another person, reader or vendor. You may skip a month after having a permanent space reserved, but you lose your permanent status after being absent 2 of any 5 shows. If you are absent due to illness and you do not have permanent status, contact me as soon as possible and we'll arrange for a transfer of funds to a future show. Sudden illnesses within 48 hours of the next show are not transferable – it's simply too late to replace your space.
- 2) **No open flame** or the burning or spraying of any incense or perfume is ever allowed.
- 3) **We operate 9am to 4pm** on the Sunday specified ahead of time. This is usually the first Sunday of every month. In 2018, this is every month except May and November where it's the following Sunday.
- 4) Those with table spaces in the center of the room have a **limitation on signage**. Nothing greater or higher than 3' may be on your table. You are responsible to display services and pricing and have available any licensing required (see below). Those around the perimeter may display larger signage and temporarily fix signs to the wall provided you do not penetrate the wall or damage the carpeted coating over the wall's surface.
- 5) **We discourage loud noises**, yelling and eating at your table space during the show. Complaints that continue beyond a warning constitutes a forfeiture of your space.
- 6) To be a **Vendor means to sell pre-made items subject to State Tax laws**. You're required to have or applied for a business license and are authorized to collect and submit sales tax to the proper state and/or local authorities. You are solely responsible for such tax collection.
- 7) To be a Reader or to be a Vendor that reads, requires two steps:

a) **Certification Required.** This involves a half hour phone session where I will ask for your birthday and you detail what you do. I ask a few questions about myself that no one knows, and upon passing, you are certified as a reader.

b) **Apply for a city of Tucson** fortune-tellers license. Forms are available through us and the City of Tucson Taxation via email. If you are a student in Arizona, alert me before applying for your license. You must secure your license within 90 days of holding a table space. The city will allow for delays if the application has been sent in. Failing to secure the license requires forfeiture of your table space.

8) Attendance. **Please be set up a half-hour prior to each show** (usually 8:30am). We hold a brief group circle 5 minutes before the beginning of each show to give news, blessings and welcomes to all. While you're required to stay until the show ends at 4pm, you may leave early with permission. You forfeit your space for future fairs if you vacate early without permission.

If you are unaware or confused by the map, please email me as soon as possible – you should be aware of how your table is placed. This is done so by priority of the hotel first, and us second.

If you wish to request a DIFFERENT SPACE: Let me know as soon as possible. I will try to accommodate you as soon as possible, but there are no guarantees for changes.

- **The Waiting List.** We will have ads in 2018 with magazines calling for new psychics or those who wish to display their spiritual talents. We also now own the Tucson Psychic Club, which has over 630 members wanting to learn and display their psychic talents. The combination of those awakening and reading the ads; plus those already interested in psychic development; want to run their own business. There can be at least 20 on the waiting list at any one time. They wait for us to move to a larger facility or for those already in to vacate their space. Your space is valuable!
