

In order to be eligible for the position, you must be a member of the respective district you are interested in running for. ## Article XIII – National Convention Roll Call Voting Procedure

When preparing for roll call votes to be cast on elections, amendments, etc., at the National Convention the vote shall be taken by paper ballot at the annual Chapter convention. Prior to the casting of ballots, the Chapter has the option to decide, by a minimum two-thirds majority of those present at the Chapter convention to vote to cast a unanimous ballot for the person, or issue, being voted on (based on the person, or issue, receiving a minimum two-thirds majority). This decision can be made as it relates to any matter, or national election, that may come before the convention. If there is no motion made, and vote taken to cast a unanimous ballot, the results of that paper ballot shall govern the procedure, by percentage, for how the Chapter's votes will be cast at the National Convention by the Chapter President. The results of the votes shall be recorded by the National Officer present at the convention, as well as in the official minutes of the Chapter convention. The National Officer and the Chapter President must send the results to the National Office within ten (10) days of the conclusion of the Chapter convention. On the issue of elections, the Chapter's official vote must be taken at the Chapter convention in the year that the election will take place at the National Convention. This procedure cannot be chapted prior to October 31, 2018, in accordance with the National Bylaws Article XI, Section 1, paragraph 14.

## State Convention

The 2019 Texas UPMA state convention is just a few months away. This year, the Wyndham Garden Hotel in Austin is the host hotel. The dates of the convention are June 20-23, 2019. I am providing a synopsis of the convention, so if a few things change, please be flexible.

On Thursday afternoon, June 20<sup>th</sup>, the Texas executive board will meet. Any guests interested in attending the board meeting are welcome to sit in on the meeting. Thursday evening, there will be a welcome dinner for all convention attendees. This will be a great time to welcome attendees from across the state of Texas and beyond. Registration will be available starting Thursday afternoon.

Friday morning, we will start the business meeting. The color of Hotel reservations can be made a Wyndhamhotels.com. Enter shirt or clothes to wear on Friday is "orange". Wearing orange will display our unity as we welcome the district management teams from across Texas. (I think I only have Aggie Maroon in my closet and no UT orange. I guess I will be acquiring an orange shirt.) There are sessions scheduled for us to meet with our designated district management teams. During the district sessions, the management teams will answer your questions. So, if you think of something to ask, write your question down. Questions will be answered anonymously, if you so desire. Training sessions will also be provided on Friday. Friday evening, we are planning a group outing. The location of the outing has not been determined. We are still in the planning stages. If you know of a place we that would be good for the outing, please let Sherry Bridges or myself know.

Saturday morning, we will have a general session. Training and a golf tournament are also planned for Saturday. Saturday evening we will have a banquet and entertainment. Recipients of the 2019 scholarships will be announced at the banquet. Scholarship applications and guidelines are available on the Texas UPMA website. Donations and auction items will be accepted for the Texas UPMA scholarship.

Sunday morning, we will start off with a non-denominational church service and a memorial service. The business session will follow the memorial service. Site selection will be voted on for the 2020 state convention. Officer elections for the vacant positions will be determined, also.

A designated hospitality room will be open for all attendees. The hospitality room provides an opportunity to play cards,



participate in money drawings, network and socialize with convention attendees.

The Texas UPMA has set aside \$10,000. to be allocated to active members and \$10,000. for retirees attending the State Convention. Chapter members on Texas UPMA travel orders are not eligible to receive a share of this fund. A cap of \$250. has been set aside per active and retiree members. In order to receive a share of the fund, members and retirees are required to register for the conference and attend all sessions. If you attend all sessions, both your District Meeting and State Convention, you will be refunded the District Meeting fee at the end of the State Convention.

code Texas UPMA State Convention 2019 in order to get the Texas UPMA hotel rates. King and double room rates are \$95. per night. Two hotel breakfasts per room night are included in the room rates. There are other room rates available in the Texas UPMA room block. The room block will be held until May 29, 2019. After May 29<sup>th</sup>, the hotel does not have to honor our room block rate. So, book your room early!! The hotel shuttle is available for transportation to and from the Austin airport.

Bring items for the PAC live and silent auctions. Funds received from the PAC auctions are sent to the National UPMA fund for future disbursement in support of representatives that back objectives of UPMA. Funds are also allocated to members and retirees that attend events of representative that back UPMA objectives.

There are committees available for all aspects of the State Convention. Volunteers are graciously accepted. We are seeking sponsors for the hospitality room and golf tournament. If you know of someone that would like to sponsor the hospitality room or golf tournament, please let Sherry Bridges or myself know.

Retirees will be honored at a luncheon. We can give thanks to all retirees who stay involved with our organization. The 2019 Lifetime Achievement honoree and the Member of the Year will be recognized at the convention. Nomination forms are available to nominate individuals for these two awards.

The State Executive Board will determine the value of the scholarships from the funds raised from the previous year contributions, money raised by the chapter, money from the endowment fund and money budgeted by the Executive Board. Applications will be judged by the scholarship committee. The names of the winning recipients will be announced at the state convention of Texas UPMA. The scholarship application is available at https://texasupma.com/scholarship. The number of scholarships is based on the money available each year so it is important we raise as much money as possible. Be sure to bring auction items to your district meeting and the state convention.

The Lifetime Achievement Award is given to a UPMA Retired member at the annual state convention of Texas UP-MA. Candidates may be nominated by any UPMA member and are judged on their service to UPMA (both State and National), USPS career service, community service, UPMA Member Retired service and any additional comments thought helpful to the committee to select the best recipient. Deadline for nominations is May 1, 2019 and can be mailed to me. The selecting committee is comprised of the Past President of Texas UPMA Retired, President of Texas UPMA Retired and the award recipient of the previous year. You can print out a copy of the nomination from at <u>https://texasupma.com/lifetime-</u> achievement-award and mail it to me.

The Retirees are also responsible for coordinating the children's activities at the state convention. Molly Williams Garwood has volunteered to assist me with planning the activities. We are looking for additional volunteers to assist us at the convention. We plan to have the entire children's activities schedule completed and available to parents when they pick up their registration packets at the state convention. #### **Proposed Bylaws Amendments**

What is the proper way according to RONR (Robert Rules of Order Newly Revised) to submit amendments to the bylaws committee? Everyone in the organization should use the same consistent format. There should be three columns: <u>Current Wording</u>, <u>Proposed</u> <u>Amendment</u> and <u>If Adopt Will Read</u>. First, type the current wording as printed in the bylaws. Second, type the words or section you would like to amend i.e. strike-out words, insert words or add words. The last column, type how the amendment will read if adopted. In additional, I would recommend that you add: Proposed by, Rational & Recommendation by the Committee

Follow the example below:

PROPOSED AMENDMENTS

#### AMENDMENT 1: CHANGE NOTICE DEADLINE FOR CONVENTION

Amend Article VI, Meeting, Section 2, Conventions, Sub-section A, Call to Convention, by striking "July 1" and inserting "February 15,"

**Current Wording:** A. Call of Convention. The call to convention, giving notice of the place, date, and time of the convention, shall be published in our national magazine and sent by July 1 of the convention year.

**<u>Proposed Amendment</u>**: A. Call to Convention. The call to convention giving notice of the place, date, and time of the convention, shall be published in our national magazine and sent by <u>July 1</u> <u>February 15</u> of the convention year.

*If Adopted Will Read:* A. Call to Convention. The call to convention, giving notice of the place, date, and time of the convention, shall be published in national magazine and sent by *February 15,* of the convention year.

Proposed by: Illinois State Unit

**Rationale:** Our National Convention is generally held in late August. The notice deadline in the current bylaws is July 1, which is too short a timeline to allow adequate travel planning and adjustment of family or work schedules.

**Bylaw Committee Recommendation:** The Bylaws Committee recommends that this amendment Be adopted. or The Bylaws Committee recommends that this amendment NOT be adopted.

## Notes from the Hill

We had a successful legislative conference. There were 17 active and retired Postmasters from Texas.

There were 361 attendees at this year Summit. Monday morning, we had training at the hotel. Megan Brennan, Postmaster General was our first speaker. She thanked us for our leadership and service. She talked about pricing flexibility to survive in today's marketplace. We need reform that allows us to compete. Medicare integration is needed. The prefunding requirement has cause financial hardship. Then she took questions from the floor.

Ron Stroman, Deputy Postmaster General was our second speaker. He talked about how much mail we deliver and do it cheaper than anyone else. He also talked about how much our mail is declining and our current financial situation. He said we need Congress to give us legislation that allow us to operate in today's world.

The afternoon we went to Dirksen Senate building for the afternoon Session. Our first speaker was Robert Taub, Chairman of the PRC, Postal Regulatory Commission. As you know, we are lacking a full 11-Member board. Current members are PMG and Deputy PMG, Robert Taub, Chairman; Tony Hammond, Vice-Chairman; Mark Acton, Commissioner and Nanci E. Langley, Commissioner.

Next, we heard from Brenda Lawrence, Congresswoman D-MI. She is great person to have supporting us. She worked 30 years in the Postal Service. She understands us. She serves on the House Oversight & Reform Committee and the House Appropriations Committee. She will do everything she can to get postal reform to the floor to make something happen this year.

Congressman, Mark Meadows R-NC, spoke to us next; he also serves on the Oversight and Government Reform Committee and is Chairman of the Subcommittee on Government Operations. He also serves on the Subcommittee on Health Care, Benefits, and Administrative Rules. Both Representatives are crucial players in helping us get postal reform reintroduced to this Congress. They have to move fast because in the next two quarters before the Presidential election cycle, because that will make it impossible to get much done. Then we went to the Russell Senate building for a reception for us and several Senators. We had several Senators drop by and visit with us. We then enjoyed dinner/caucus together at Hawk N Dove.

Tuesday was spent on the Hill, meeting in 38 Representatives offices and our two Senators offices. We broke up into groups making sure every district was represented. This year, a large number of our group was able to meet with the congressman or congresswoman. I would like to add that we also met with a lot of very important Postal legislative aides. We shared our talking points and asked them if they would Co-sponsor H.R. 33, In addition, bills to watch, H.R. 141 and H.R. 597. All in all, our meetings went well, and we felt positive about our visits and the opportunity for support for postal reform.

UPMA is here to ensure that the United States Postal Service remains an independent establishment of the Federal Government and is not subject to privatization.

## **UPMA 2019 Membership Contest**

A great new way to make some extra cash while also helping the membership of UPMA has just opened up! This is a perfect opportunity to help out Postmasters, Managers and Supervisors as well as craft members who are possibly interested in an EAS position in the future. Being an active UPMA member has helped me to always know the latest information in addition to having an excellent pool of resources when needed. Why not take this chance to also make some extra money at the same time?

This is how the contest works:

The UPMA Chapters have been divided into six groups based on time zone and chapter size. The contest runs from January 1, 2019 thru June 30, 2019

It consists of four components:

• <u>Individual</u> – Each time a member signs a new member and is listed as the **Sponsor/Person influenced your decision to join UPMA** their name will be submitted in the drawing held at the national convention, the more you sign the more entries submitted. Five entries will be drawn at the convention; each entry drawn will receive \$100. You are eligible to win more than one time.

<u>Within each of the six groups</u> there is a competition between the chapters for the most points earned by signing new members. To level the playing field since the UPMA chapters vary so much in size and new member opportunity the following rules apply on *how to score points*.

The top performing UPMA Chapter Group determined by the highest point total of all chapters within each group *divided by the number of chapters* in the group.

UPMA Chapter Group Award:

Each chapter in the winning group will receive \$.50 cents per member as listed in the total member column on the 07/01/2019 Membership Status Report.

And finally, the Grand Prize: Special UPMA Membership Achievement Award Trophy to the Chapter with the most earned points to be presented at the National Convention.

#### THIS WILL BE A NEW SECTION

Current Wording: There is no current wording

#### If Adopted Will Read:

TEXAS UPMA MEMORIAL SCHOLARSHIP FUND

The scholarship fund of the chapter will be known as the Texas UPMA Memorial Scholarship Fund.

- The Texas UPMA Scholarship committee will be made up of the Scholarship Chair and one UPMA member from each Texas Postal District. At least one member of the committee must be a Texas UPMA Retiree.
- The Texas UPMA Executive Board will control the investment of the fund. The Secretary-Treasurer will report the investment funds value and balances at each Executive Board meeting. An annual report will be presented to all members during the business session of the annual state convention.
- Scholarships will be funded by contributions, fundraising, interest earned by the endowment fund and any funds appropriated by the Executive Board. The number of scholarships awarded each year will be determined by the Executive Board prior to or at the chapters annual state convention.

The Endowment Fund value will be maintained at ninety thousand dollars (\$90,000.00).

- An application, award letter and letter directing applicants on how to secure payment will be developed by the committee and approved by the Executive Board.
- Eligible applicants must be children, step children, grandchildren or step grandchildren of Texas UPMA members, retired Texas UPMA members or deceased Texas UPMA members entering their first year of college or trade school.
- The Texas UPMA Memorial Scholarship Fund will accept applications postmarked January 1 through May 15 of the year in which applicants are applying.
- The Scholarship Committee will meet during the chapter's annual state convention to review the applications. They will be judged on financial need, extracurricular activities, and scholastic achievement. The scholarships will be awarded at this chapter's annual state convention. An announcement will immediately be sent to each winner's local newspaper.
- ALL payments for awarded scholarships will be made directly to the Financial Office of the institution the applicant is currently attending. NO payments will be made directly to the applicants.
