Each AAA team may enter four (4) singles players; Each AA team may enter three (3) singles players. Both AAA & AA may enter three (3) doubles teams. D10 sends one (1) singles and doubles winner from each level. Singles winners may not participate in doubles.

TOURNAMENT RULES AND PROCEDURES

- 1.) USTA Rules apply to all matches. A certified referee will be on-site to enforce rules.
- 2.) Each match is an 8-game pro set, regular scoring, with a 12-point tiebreaker at 8-8. No coaching is permitted.

The semi-finals and finals are best 2/3 tiebreak sets. Coaching is permitted during the 2-minute break after the 1st set and the 5-minute break between the 2nd and 3rd sets.

- 3.) Schools must send a representative for all events. Coaches are responsible for on/off-court behavior of all players, parents, and spectators. The T.D. may eject anyone displaying inappropriate behavior/poor sportsmanship. Individual schools are responsible for any facility damage. Black-soled, marking shoes and soda are not permitted on-court.
- 4.) A \$5/day PIAA D10 admission fee will be charged for spectators.
- 5.) Official PIAA D10 Long sleeved t-shirts will be available (\$20).
- 6.) The Coaches Meeting will be at PAC Sat, Oct. 7, 9:30am to seed and develop draw. Entry deadline. **** Please email/mail entries/eligibility by Oct. 3, 9pm.**

A \$25/day late registration fee may be charged to the school.

- 7.) **AAA & AA doubles seeding/draw meeting: Tues., Oct. 10, 7:00pm, PAC.**

8.) PIAA D10 alternates will be 2nd place finalists.
