# **ADMINISTRATION**

- Pete welcomed new committee member Steve Hoover, who will represent the athletic directors for the next two
  years
- Pete thanked all tournament directors, game managers and workers for their help and assistance with the Spring Sports tournaments
- Cross Country Tournament Director was discussed.
  - Motion by Hoover, second-White to have Barb Dzuricsko named as the new CC Tournament Director Motion passed unanimously
- Review provided of the Spring Tournaments
- Approval of 2019-2020 District 10 Handbook
  - Motion by Taylor, second-Scurpa to approve the Handbook for the coming year
  - Motion passed unanimously
- Cross Country Venue
  - Discussion held about returning to Buhl Park, as those associated with the Park had questioned whether they wanted to host again in 2019. Buhl Park later agreed to bid on hosting again. Browns Farm was the only other facility that provided a bid for the tournament.
  - Motion by Scurpa, second-Vannoy to return to Buhl Park for the 2019 event
  - Motion passed unanimously
- Cross Country Scoring Modification
  - The state has examined using a modification to scoring that would include permitting less than five runners on a team being able to win a meet.
  - Motion by Vannoy, second-Come not to have District 10 adopt these scoring modifications
  - Motion passed unanimously
- St. Mikes (Greenville) Membership request
  - This had already been passed at the PIAA level.
  - Motion by Rimpa, second-Scurpa to approve the membership
  - Motion passed unanimously
- Co-op Termination: Franklin Junior High and St. Pats. St. Pats no longer exits
  - Junior High Boys: Soccer, Cross Country, Football, Golf, Track and Wrestling
  - Junior High Girls: Soccer, Cross Country, Track, Softball and Volleyball
  - Co-op Request: Iroquois (host) with Mercyhurst Prep and Erie First in Wrestling
  - Co-op Termination request: Rocky Grove and Venango Catholic in Girls Basketball
  - All three of these co-ops were already approved by PIAA
  - Motion by Gignac, second-Hoover to approve the three co-ops
