- Ejection Rule Revision, Sub Varsity Football options
Chairman Iacino explained how the new ejection rule will work and explained the sub-varsity adjustments
- District 10 Passes (delay issuance)
Motion by Piddington, second—Vannoy to delay the issuance of D-10 passes until we have an update on games this season
Motion passed unanimously
- Authorization of the Chairman and/or Executive Committee to act on eligibility cases between Committee meeting dates
Motion by Hoover, second—Come to approve authorization
Motion passed unanimously
- Meeting Schedule for 2020-2021
Dates: August 5, September 9, November 11, January 13, April 7 & April 23
Pete noted this schedule could change based on our current situation
- Games not played due to Covid-19 concerns: non-games/forfeits
Chairman Iacino believes all games not played due to Covid-19 concerns should be considered non-games

Motion passed unanimously
- Change in Mercy rule for Basketball 30-point differential in second half (from 40-point)
Change was noted
- Approval of 2020-2021 District 10 Handbook with change
Discussion was held, mainly regarding a change in policy that school dues would not be paid if schools did not adhere to five different points related to school attendance, involvement in District matters, updating power rankings and complying with PIAA rules and regulations
Motion by Scurpa, second—Flanagan to accept motion as presented
Motion passed 8-7
Motion by White, second—Scurpa to approve the D-10 Handbook
Motion passed unanimously
- Considerations for District 10 Playoffs
Discussion was held regarding a reduced playoff format and the loss of revenue due to no fans in the stands with Chairman Iacino mentioning games will likely have to be held at home sites. Alterations would likely have to take place in tennis, golf, football, volleyball and soccer

Chairman Iacino asked for written comments from tournament directors in advance of the next meeting
No action was taken

- Team Bracketing Rules 2020-2021 & 2021-2022 and Brackets
Chairman Iacino asked that this be conditionally passed knowing things could change with the virus

Motion passed unanimously
- Payment of Spring Tournament Directors
Since there were no spring tournaments held, none of the tournament directors were compensated for their work in advance of tournaments

Motion passed 13-0 with three abstentions
- Membership Application of The Learning Center (k-8) Meadville
Motion by Scurpa, second—Taylor to approve membership of the Learning Center
Motion passed unanimously
- Assignment of Playoff Officials (Arbiter)
Jim discussed how current assignors in D-10 are using Arbiter in the regular season and how some are using it for the postseason
No action was taken
- Co-op (pending proper paperwork) Maplewood Jr. High and The Learning Center in Boys' football, Boys' basketball, Boys' volleyball
Proper paperwork has been turned in
Motion by Scurpa, second—Rimpa to approve Co-op
Motion passed unanimously
- Return to play protocols
Chairman Iacino went over the school to school communication guidelines for return to sport competition that was issued by PIAA. Cancellations due to Covid-19 must be communicated by a school's principal.
Communication is paramount
- Start Date for All District 10 Schools
Chairman Iacino explained the three different options, offered by PIAA, that District 10 can take to start the athletic year. The options are regular start, alternate start and hybrid start
The responses from a survey sent to District 10 superintendents were detailed.
Chairman Iacino also reiterated that the District 10 committee has no authority to cancel a season. The committee has authority over scheduling and the D-10 playoffs
Motion by Flanagan, second—Scurpa to proceed as normal with the D-10 start schedule, noting individual schools can make their own decision

- Kennedy Catholic use of ineligible players in football
Kennedy Catholic used multiple ineligible players in football. They were asked to forward an explanation regarding the issue on more than one occasion, but District 10 has yet to receive it.
Motion by Piddington, second-Vannoy to place the Kennedy Catholic football program on probation for one year from the date of the infraction and require the school's administration to submit a corrective action plan

Motion passed unanimously
- Review of Recent Events
The Chairman updated the committee on recent events, such as injunctions filed by several golf parents, which ended up in court. District 10 and PIAA's position was upheld in court. The issue of McDowell withdrawing two golfers, then attempting to re-instate them into the D-10 golf tournament was also discussed. Also mentioned how the amount of incorrect forms the committee receives for things such as transfers appears to be increasing.
- North East Junior High Report of use of ineligible player in football
North East played a student who did not have the proper CIPPE documentation on file. They notified the other school (Seneca) and forfeited the contest.
Motion by Piddington, second-Rimpa to accept the action taken as a forfeit
Motion passed 12-0 with one abstention
- Update Report regarding Kennedy Catholic-Mercer girls soccer game
Kirk updated this situation of how the Kennedy girls team walked off the field on September 19th at halftime for no good reason. The coach quit on the spot when confronted with the issue. The school made the players write letters of apology to Kennedy and do service hours for the indiscretion. The school was placed on probation for one year, which included what could happen to the school should further infractions occur.
- Update Report regarding Kennedy Catholic use of ineligible players in football
Four players participated in a game prior to being ruled eligible by the District 10 Committee.
- PIAA Update
Change in brackets and qualifiers. Chairman Iacino mentioned how the amount of cross country qualifiers for the PIAA race was increased.
Fall regular season play deadline saw schools provided the option to continue playing games through Thanksgiving in football provided they do not exceed the regular season number of games they are limited to. The spring option for schools to play also passed.
Steve Hoover provided an update from PIAA on what they are doing with winter sports, specifically with wrestling. The number of qualifiers and how tournaments would be held was also mentioned. PIAA Sports Medicine will eventually offer recommendations.
Chairman Iacino discussed possible protocols that were mentioned in a PIAA steering committee meeting in basketball. He also briefly went over possibilities for postseason basketball and how to run swimming events.

- Hosting a Playoff Game Fall 2020
The Chairman went over the new document that entails protocol for hosting a playoff game in sports such as football, soccer and volleyball. A lengthy discussion was held regarding live streaming. No action was taken.

- Fairview co-op modification for boy's lacrosse. Currently with Girard and North East. Request change to Girard and General McLane
This was already approved by PIAA. Motion by Vannoy, second-Rimpa to approve the co-op
Motion passed unanimously
- Tidioute Charter will be unable to field a PIAA Girls' Basketball Team for the 20-21 basketball season due to low numbers
Pete updated the group that Tidioute Charter will not field a team in girls basketball this season due to low participation numbers
- Grove City enhanced ejections of coach and one player in boys' soccer and failure to complete requirements for reinstatement of eligibility. Played at least 10 games after the 2-game suspension
With a change in the 'enhanced' rules on ejection, classes must be taken by those impacted. In this instance, Grove City's head coach and player, who were both ejected in the first match of the season, did not complete mandated classes through the NFHS. Grove City sent a correspondence, noting not enough information was provided on what they were to do in this case.
Motion by Piddington, second-Come to have Grove City forfeit any wins over the timeframe when their coach and player participated following the initial ejection and to place the boys soccer team on probation for a period of one year.
Motion failed in a roll call vote 12-3
Motion by Flanagan, second-Wigton to ask for a time-stamped email from Grove City regarding their response to the multiple ejections.
Motion passed in a roll call vote 11-4
- Winter Sports/Winter Playoffs
Pete gave an overview of winter sports and a possible look at the postseason. Some of the initial plans for a winter postseason were altered by the new Governor's order, limiting building capacity. Brief updates were provided on basketball, swimming, and wrestling. Some schools are switching to completely virtual.
- DOH Masking Order
Pete provided an update on the masking order, noting PIAA's job is not to enforce it. Enforcement resides with individual schools.
- PIAA Update
As previously discussed, and as of now, the winter sports season will begin on time while the fall season officially closes this Thanksgiving weekend.

- Competitive Cheer
Was scheduled to take place January 9th; it has been moved to April 8 or 9.
- Wrestling
Alterations were made to include only District champions in team play. Individuals will move from 20 qualifiers to 8. Each tournament (Sections/Districts/Regionals) would permit only 8 individuals in each weight class. The objective is to make all tournaments conclude in one day, not two days.
- Basketball
Approved champions only advancing to the PIAA playoffs. Thus, the first round of interdistrict play will begin on March 16th. This adds an additional week to the season while not adjusting the original date of the state championships.
- Swimming
Will have the final qualifiers cut in half, moving from 32 to 16. District champions will qualify to go to the finals with the next best four times moving to states. As it stands now, Bucknell University would host the event without fans.
- Update on D10 Schools playing, not playing, and delaying
The Chairman provided an update on schools that are not playing on time. George Junior is the only school which has opted out of winter sports for the season. Five D-10 schools have not responded to a survey indicating their start time for the season.
- Regular Season Forfeit/No game
PIAA passed that any game not played due to a connection to COVID, the contest is simply 'no game' as opposed to a forfeit. Same with schools refusing to wear a mask in a contest. Will be termed 'no game' and not a forfeit and emphasized how communication here is key.
PIAA also passed a new practice rule due to shut down. If you missed 7 or more consecutive days, you must have two practices before you can play games. If you missed 10 or more consecutive days, you must have three practices before you can play games. If you missed 14 or more consecutive days, you must have four practices before you can play games. PIAA also extended the regular season through March 27th, as long as schools do not exceed the maximum limit on contests allowed.
- Regular Season Region Games Schedules
District 10 is not making any recommendations aside from play when you can play as we stand now. Schools need to be ready to pivot due to the virus.
- District 10 Playoffs
District 10 is not prepared to unveil any postseason plans. Too many unknowns currently. Pete indicated

tournaments might be by invitation only depending on how the season plays out.
