

Nonprofit Insurance Trust - Property & Liability Pool Motor Vehicle Record (MVR) Demerit Point GUIDELINES

The purpose of these guidelines is to enforce an eligibility reference of acceptable driving standards utilizing a demerit point system in determining acceptability of prior moving violations of current and/or potential employees of your organization. The table below represents a five (5) year violation history within the calculation. Violations are determined by severity of offense and decrease in point value over time. While the final determination of any person(s) driving on behalf of your organization rests within your responsibility, and person deemed not acceptable by point value may be considered by submitting this completed table along with an explanation to the Nonprofit Insurance Trust for insurance company approval.
