City Auto Glass is our Preferred Shop for glass only claims throughout the state of Minnesota.

### **TO STREAMLINE THE PROCESS FOR GLASS ONLY CLAIMS:**

- If the repair is for glass only, you do not need to submit a claim through the NIT website
- The insured member shall contact City Auto Glass at 1-888-552-4272 (all locations statewide), or another shop of their choosing and provide the shop with:
  - Date of loss
  - NIT policy number
  - Year, make, model and last four digits of the vehicle identification number
  - The specific glass damage that is to be repaired

### **THE SHOP WILL:**

- Contact Nonprofit Insurance Trust to verify coverage on the vehicle and approve repairs
- Coordinate with the insured member to complete repairs
- Email or fax the invoice for repair directly to Nonprofit Insurance Trust for payment
