ENTERING THE TRIAL

Wherever the word "dog" is used in this premium, it includes both sexes. These tests are open to all dogs six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP prefix), an AKC Canine Partners listing (MA prefix) or are approved Foundation Stock Service (FSS) breeds. Rottweilers are given entry preference in all tests.

Entry Fees and Information for Entering

Variable Surface Tracking Test (includes \$3.50 AKC recording fee) \$125.00 Entry fees are to be in US Dollars only.

Express mail entries must include the signature waiver allowing them to be left at the secretary's address. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Illegible entries will not be processed and will be returned to the exhibitor.

Errors on Entry: Owners are responsible for errors on entry forms, whoever may make such errors. No entry fee will be refunded in event of errors. Entries cannot be accepted, canceled, altered, or substituted after the entries have closed.

Receipt of entries will be acknowledged via email (when a valid email address is provided on the entry form).

Refunds, Alternates List, Bitches In Season

100% of entry fees will be refunded (checks destroyed) for any reason if written (or email) request is received by the TEST SECRETARY on or before the closing day and time.

No entry fee will be refunded if the test cannot open or be completed by reason of riots, civil disturbances, fire, an act of Loki, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

In the event an accepted entry cancels following the closing of entries, the Test Secretary shall contact alternates according to their placement on the Alternates List. Upon such notification, alternates shall have the option of accepting or refusing the opportunity to participate in the test. In the event an accepted entry is absent on the day of the test, it shall be the responsibility of the Test Secretary to determine if alternates are present and, by their position on the Alternates List, determine which of the alternates shall participate.

Entry fees will not be refunded in the event a dog is absent (see below), disqualified, excused by a veterinarian or judge, or barred from participation by action of the Test Committee. Bitches in season may participate per Ch2, Sec 8, Tracking Regulations.

Entry fees will be refunded for: (a) an alternate who does not participate, and (b) an entry who is absent by virtue of having earned, after the close of entries, the title for the test in which entered, provided a properly entered alternate is available and runs said track.

Refunds will be mailed within fourteen (14) days following the test.

Draw

In accordance with AKC Obedience Regulations, entries in these tests will be accepted up to the official closing date and time, even though the advertised limits may have been reached.

Should the number of entries exceed the number of tracks available, a drawing to determine which entries will participate in the tests will be held Wednesday, April 3rd, 2019 at 7:00 PM MDT at Starbucks Coffee, 815 E 17th Ave Unit C-5, Longmont, CO 80501. Any interested parties are welcome to attend.

The drawing for participation will be conducted by the Test Secretary and shall be completely random among all entries received, except that Rottweilers will be drawn separately and given preference over other breeds and All-American dogs. Preference shall be given to dogs that have not earned the title for the test they are entering.

When the advertised limit for each test has been drawn, all of the remaining entries shall be similarly drawn and assigned a position on the appropriate Alternates List, subject to the same preference set forth above. The Test Secretary shall then notify all entries of the results for the drawing. If one portion of this test does not fill and there are properly entered alternates for the other portion, track types may be exchanged in accordance with Chapter 1, Section 12 of the AKC Rules, at the discretion of the Club.

INSTRUCTIONS 1.(Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard). 2. (Event Class) Consult the classification in this premium list.
