




President's Letter

As one of the original members, I have seen HCCC go through many, many of its growth and muscle flexes and I know it is going through another as we again change locations. We are electing new officers to take HCCC into its next period. When the Club received its State Charter in 2002, its primary purpose was to establish the group so we could protect ourselves through liability insurance as we conducted cruise-ins and other car related activities. It was not intended to establish the group as a business or charity but only as a non-profit, non-tax-exempt entity. Our paperwork has been filed each year (I don't remember it changing) as such. Again, it is up to the membership to decide which way we want to go. We do need a number of members to step up if we want to continue with major programs or do we want to back down to minor activities (cruise-ins and small fund raisers) and do less with less money. We can still support local charities with somewhat less without trying to work ourselves so hard. We do have reasonable club income with our membership dues (\$25 yearly) and our trailer advertisements and with simple support. We could do small fund raisers at cruise-ins. I do not feel good when we raise money through activities telling people we are doing this for charity and we spend on ourselves or member prizes or accolades. We have had a very, very good working relationship with local businesses and I would like to see it continue at the highest level.

I personally do not like to see individuals rewarded for doing something for the Club or a charity. I feel they did it for all the right reasons, "it needed to be done," and/or "I want to do it because it will be self-rewarding." We have some wonderful people in this group and most respond extremely well if they are given a "thank you." We also have many, many who prefer to work quietly and just get things done.

I am adding a short note, as I remember it from my grandfather.
