Idle-Hour Ranch Permission, Release & Hold Harmless Agreement

I, [print full name] _____, in consideration of being allowed to participate in the intern service of Idle-Hour Ranch (IHR) have read and understand the policies outlined in the IHR Intern/Volunteer Handbook and do hereby agree that:

1. **Internship/Service Agreement:** As an intern/volunteer, I understand and agree to assist IHR staff and management with various phases of IHR operations, that are not always necessarily in direct focus of my preferred internship, in order to achieve a broader understanding of my field of study in relation to its function within the workplace. I certify that I am capable of performing jobs which may be of a physical nature, requiring activities such as kneeling, crouching, bending, walking, standing, lifting, etc. As an intern/volunteer, I understand that it is my responsibility to maintain a positive and respectful attitude at all times; conduct myself with utmost professionalism, and pull my weight as a self-motivated team member. I fully understand and agree that this is a volunteer position, meaning that I am donating my services to IHR in exchange for valuable learning and experience. I agree and fully accept that no compensation is given for my services. I understand, acknowledge, & agree that my position with IHR is voluntary and unpaid. I understand that housing, medical insurance, transportation and any form of compensation for my expenses, is not provided to me by IHR, and I am responsible for finding transportation to and from IHR to meet my hourly requirements; failure to arrive in a timely manner on days I am scheduled to work, or days that I fail to show without previous permission from my supervisor, may result in my expulsion from the IHR internship/volunteer program without credit. Furthermore, I understand and agree that it is my sole responsibility to ensure that all university or college requirements are met to receive credit, and that in order for IHR to assist me in achieving credit for the work I have completed that it is necessary for me to provide IHR with all of the relevant paperwork prior to my internship. I hereby acknowledge that it is my sole responsibility to read the IHR Handbook in its entirety prior to my first work day with IHR and agree that I will abide by all of IHR's policies and procedures outlined for me within my handbook, this application packet, and by management, and release IHR from all responsibility concerning credit fulfillment or completion.
2. **Photo Authorization Release:** I hereby grant permission to IHR, and its officers, trustees, employees, agents, students, representatives, successors, associates, licensees and assigns to photograph/video my image, likeness, or depiction and/or that of my minor children (if applicable). I hereby grant permission to IHR to edit, crop, or retouch such photographs, and waive any right to inspect the final photographs. I hereby consent to and permit photographs of me to be used by IHR worldwide for any purpose, including educational and advertisement purposes, and in any medium. I understand that IHR may use such photographs with or without associating names thereto. I further waive any claim for compensation of any kind for IHR publication of photographs, videos, or images of me.
3. **Health Certification & Policy Agreement:** I certify that I am in good health, have had no recent exposure to a contagious disease and have had no operations or serious illness that would interfere with my responsibilities as an IHR Intern. I am capable of lifting a minimum of 50lbs at a time, and am able to stand, walk or sit, for longer than 30 minutes at a time. I understand that I may be working both indoors and outdoors and it is my responsibility to wear appropriate clothing/gear to protect myself from the elements and possible health hazards within the work area. I also understand that it is my responsibility to notify IHR supervisors of any health requirements or issues while interning/volunteering at IHR, and IHR is not responsible for any safety-related accidents or damage to my health as a result of my negligence and/or irresponsibility in abiding by company policies, procedures, or safety requirements provided by IHR. I am aware and hereby acknowledge, that in accordance with IHR policy, I am not permitted to participate in any animal handling or public interaction with IHR while sick, or after the suspected event of exposure to a contagious disease. I understand that I am required by IHR to take "sick days" while contagious or otherwise ill so as to protect IHR animals, staff, and clientele from exposure, as well as to safeguard my own health; and I understand that these sick days taken off will affect my overall hours and time requirements which may cause me to have to make them up in order to receive full credit. I understand that IHR takes this very seriously and may send me home without credit for the day if I show up while sick, and that this action may cause me to lose my internship/volunteering position with IHR. I also understand that falsified sick days are strictly forbidden and will be considered grounds for immediate expulsion of IHR's intern/volunteer programs, I will lose all credit for my internship with IHR, and my professor/advisor will be notified of the expulsion.
4. **Alcohol & Drug Policy Agreement:** I understand that IHR has a strict non-tolerance Alcohol & Drug Policy. Any and all involvement with IHR may be contingent upon successful completion of a pre-employment physical examination which may include a blood, urine and/or other medical test for alcohol, drugs & controlled substances. Also, proof of negative TB test results from within the last 9 months, as well as proof of receipt of Tetanus vaccine within the past five years, are required prior to internship. I further understand and agree that IHR may require me to submit to a drug and alcohol screen after I am employed. Prior to testing, I agree to sign IHR's authorization forms wherein I will agree to submit to such testing and to authorize the release of the results to IHR. I further understand that failure to do this may result in the immediate termination of my involvement with IHR.
5. **Release for Medical Treatment:** I authorize IHR and emergency medical personnel to provide and render necessary medical care and treatment to me for any illness or injury, which I may suffer at any time while in their custody. It is understood, that time permitting, specific permission of the parent/guardian will be secured in the event that any major medical treatment or surgery is to be undertaken, but that should an emergency arise, this authorization and consent will cover such an event. As a participant of IHR activities, events, and day to day duties, I am fully aware and have a complete understanding that potentially severe or catastrophic injuries may be associated with any and all IHR activities including, but not limited to, animal handling, machine/vehicle operation, and other possible farm-related injuries. I hereby release IHR, its owners, officers, trustees, employees, agents, students, representatives, successors, associates, animals, licensees and assigns from all liability for any and all damages and injuries I have suffered while under instruction, supervision, internship, performances, or control of IHR or while at any of its offsite events, business affiliates, or performing or practicing facilities. I fully understand that IHR provides no medical coverage for this activity and that I will be financially liable for any medical care and treatment rendered. I hereby agree to individually provide for the possible future medical expenses which may be incurred by the aforementioned person or animals as a result of any injury sustained while interning, training, or volunteering with IHR, while on property, and off.
6. **Hold Harmless Agreement:** I, for, and in consideration of, IHR's Internship/Volunteer program, and for myself, my heirs, executors, administrators, personal representatives, successors and assigns, agree to hold harmless IHR, it's owners, agents and employees, for itself and all other persons or organizations, both known and unknown, specifically including any agents or employees of the undersigned for all claims and damages, actions and causes of action, costs, damages, loss of use, loss of consortium, loss of services, expenses, compensation, or any other thing whatsoever on account of, or in any way growing out of, injuries or damage resulting from an occurrence or accident that may take place, or any other matter attributable to, the above named activities. Either for myself, or my

property. I understand that IHR and its owners are not responsible for the safety, nor liable for the loss or damage, of any of my property; and I understand that it is my sole responsibility to take the necessary precautions to keep myself and my items/property safe. I hereby

grant permission to IHR for the use and production of any and all work projects, documents, tasks, posters, brochures, designs, graphics, images, digital media, marketing concepts, campaigns, websites, programs, articles, and all other proposals and assignments that I produce on behalf of IHR during my internship/volunteer service, and I hereby hold harmless IHR and its owners, staff and affiliates in agreement that these aforementioned projects become the sole property of IHR, to be used at will by IHR, without my notification, permission or compensation; and I release these projects to IHR of my own free will, voluntarily, and without duress.

7. **Background Check Release & Agreement:** I understand that IHR reserves the right to conduct reasonable criminal background screens and driver's license checks on all placed interns; and my offer of internship/volunteer service is contingent upon passing these screenings. Therefore, I agree, authorize and consent to the release and disclosure of any, and all, of my information to IHR including my social security number, date of birth, driver's license number and the state in which it was issued, as provided on my IHR Internship Application.
8. **Searches & Video Surveillance Acknowledgement, Consent & Release:** I understand that IHR reserves the right to observe employees throughout the Company's premises, either by way of direct observation or through the use of electronic devices. IHR has installed video cameras to monitor reception areas, work areas and/or other generally open areas where employees may be seen by others. I acknowledge that I have received a copy of Idle-Hour Ranch's policies, that I have been given the opportunity to read and ask any questions that I might have about the same, and that by signing this acknowledgement, I agree to adhere to the policies as a condition of my internship/volunteer service and/or continuing internship/ volunteer service with Idle-Hour Ranch. I understand and agree that in acknowledging and signing this form, no contract of employment, paid or otherwise, is hereby created, and further understand that no promise or guarantee of employment, internship/volunteer service for any particular term is hereby made. I also acknowledge that I am an intern/volunteer-at-will and that either I, or Idle-Hour Ranch, may end the service relationship at any time, with or without notice or cause. I further acknowledge that my failure to adhere to these policies may subject me to disciplinary action, up to and possibly including immediate termination of my involvement with IHR without warning. In accordance with Idle-Hour Ranch's policy regarding searches, I understand that all desks, storage areas, lockers, and all vehicles owned, financed, or leased by Idle-Hour Ranch or used by Idle-Hour Ranch to transport employees, goods, and/or products are subject to search at any time without my knowledge, presence, or permission. With the exception of my personal vehicle, I understand I am prohibited from locking or otherwise securing any such desk, storage area, locker, or vehicle with any lock or locking device not supplied or approved by Idle-Hour Ranch. I acknowledge, understand, and agree that I am privileged to have this opportunity to work with IHR and be a part of their team. Only the owner of IHR has the ability to adopt any revisions to the policies in this handbook. Furthermore, I understand that this handbook is neither a contract of employment or service, nor a legally binding agreement. I have had an opportunity to read the handbook, and I understand that I may ask my supervisor or any IHR Administrator any questions I might have concerning the handbook. I accept the terms of the handbook. I also understand that it is my responsibility to comply with the policies contained in this handbook, and any revisions made to it. I further agree that if I remain with IHR following any modifications to the handbook, I thereby accept and agree to such changes. I also understand that failure to comply with any and all policies, Standards of Conduct, and/or Company Work Rules outlined within this handbook is immediate grounds for expulsion from IHR.
