He was in the battles of Monmouth, King's Ferry and many skermishes at various times, he being on detached parties. He is a farmer, infirm and rheumatic and unable to support his family.

Was discharged at West Point. In 1781 enlisted for three years under Capt. Luther Kelly, Coal. Ebenezer Mount and was discharged at Philadelphia, the last of 1783. His discharges were destroyed by fire in a house which burned. He has never had a pension.

He applied for pension May 16, 1818 and was granted certificate #8352 dated March 25, 1819.

Nathan Davis, 3d. has a pension #12392 dated April 20, 1819.

Made application for pension and has certificate #4005 dated October 29, 1818.
DUNNING, Michael	Ulysses	70	May 23, 1821	He has a wife, ae 57, not named, also infirm; two sons, 15 and 13 years of age, not named. He is a farmer, but cannot work, due to age and infirmity. He served about two years, when he was taken prisoner on an island in Lake George, by British and Indians. He was taken by the Indians to Montreal and delivered to the British there. He was held there about three years, when he was exchanged. While he was a prisoner, he was raised to the rank of Captain, but as he did not rejoin the Army, he never took command. He was in the Battles of Bennington and Hubbardstown. He applied for pension, April 18, 1818, granted December 23, 1818.
